### MINUTES OF THE 144<sup>TH</sup> ANNUAL PENNSYLVANIA STATE GRANGE SESSION

#### FRIDAY, OCTOBER 21, 2016

- 1. The 144<sup>th</sup> Pennsylvania State Grange Annual Session officially opened in the 6th degree on Friday October 21, 2016 at 9:00 AM at the Tuscarora Room of Reisner Hall, Shippensburg University Campus, Shippensburg, PA with President Elizabeth Downey presiding. The opening drill was under the direction of Andrew Kieffer, Assistant Steward from Berks County.
- 2. President Downey introduced Secretary of Agriculture Russell Redding. He is a former Dean of the School of Agriculture and Environmental Sciences at Delaware Valley University formerly Delaware Valley College. Secretary Redding has spent more than 20 years representing Pennsylvania agriculture as a public servant in Harrisburg and Washington D.C. A native Pennsylvanian, Redding grew up on his family's dairy farm and now operates a general crop farm in Gettysburg with his family. He is a graduate of Penn State's College of Agricultural Sciences. Secretary Redding provided information he feels is imperative for the Pennsylvania State Grange to consider. What is important to rural Pennsylvania and the mission of the Grange and what is seen in our local communities? One question would be what is the future of Agriculture? Secretary Redding stated that Grange has deep roots in agriculture.

With the budget issue of the state, it has caused the credit rating to be reduced. This caused the state to pay more in interest which resulted in less money to be used elsewhere. The credit rating due to recent financial practices has been raised and we can now use more funds in other areas.

When crossing the Chesapeake Bay Bridge and you look down, 90% of that water is from the Susquehanna River. 50% of the water in the Bay is from the Susquehanna River. The challenge is that river runs through the heartland of Pennsylvania agriculture.

We have an amazing state but mindful that there is a higher power. These are extraordinary times. Challenges to find the equilibrium behind them. Grange has a voice with the legislature and agriculture.

- 3. President Downey announced that the Department of Agriculture has been chosen to receive the "Friend of the Grange Award" and presented a plaque to Secretary Redding for the Department of Agriculture.
- 4. Sister Lizzie Bailey, Committee Chairperson of the 2016 Host Committee, welcomed everyone to Shippensburg, Cumberland County, Pennsylvania. Pennsylvania State Grange Session was hosted by the South Central Convention District. Sister Bailey introduced
  - a. Dr. Jody Harpster, Shippensburg University President, welcomes the Grange to their campus. Apologized for the issue with the college today. It is an honor to be here today for the work you do every day and back in your communities. Shippensburg is celebrating its 146<sup>th</sup> year of operation. Shippensburg University was founded in 1871 as the Cumberland Valley State Room School to educate future teachers and to serve the local community. The Pennsylvania State Grange was organized two years later in 1873 to advocate to the betterment rural America with community service and education at the heart of those efforts.
  - b. Mayor Bruce Hockersmith, stated it is an honor to have the Pennsylvania State Grange in Shippensburg. Shippensburg in the early 1800's was an agriculture center and provided food and

grains for the entire Cumberland Valley. It is important that you are here to help us celebrate what farming does for America. Mayor Hockersmith presented the Pennsylvania State Grange a proclamation from the Borough of Shippensburg.

- 5. President Downey thanked Sister Lizzie Bailey, Committee Chairperson for her courage, strength and determination and her committee for all they have done for this convention. Sister Bailey stated it takes a whole state to do this convention. She also stated that her committee took their task and ran with it to bring this convention to you.
  - a. Sandy Sellers, Executive Assistant to the Vice President of Marketing & Corporate Finance and Sales and Support of Volvo Construction Equipment Company. There will be two presentations at the Convention Center on their journey of Volvo Construction Equipment and where they come from. Volvo Construction Company donated \$5,000 to the Convention.
- 6. Roll call found all officers present. Doris Evans served as the pianist for the session.
- 7. Honored guests recognized were National Grange Ceres Clare Logan and husband Steve, Past Master, Overseer, Executive Committee Member and Chaplain of Rhode Island State Grange. Sister Logan thanked Pennsylvania for the invitation and wishes us a great convention. Brother Steve said he is glad to be here and looking forward to more at your state session and wish you the best of luck.
- 8. Also recognized as honored guests were Carl Meiss, Past Master of the Pennsylvania State Grange Past First Lady and Past National Priestess Annalist, Fae Snyder.
- 9. Sister Nauss gave us devotions on stability and respect. Matthew 7:12 reminds us of the golden rule, "So in everything, do to others what you would have them do to you. As we engage in discussion with our fellow Grangers this weekend let us be reminded that respecting someone is not the same as agreeing with everything that he or she may believe. Think before we speak...T=think, is it true; H=Is it helpful; I=Is it inspiring; N=Is it necessary; K=is it kind. So as we begin this State Session, let us remember that although we may have difference in opinions we are united in purpose to do the work of this great organization that we all love.
- 10. Appointment of Session Committees—Credentials—Shirley Burkhart and Judy Moyer Sister Burkhart gave a partial report of the Credential's Committee as follows:
  - 125 Delegates and 80 Subordinate Granges and
  - 46 Delegates and 33 Pomona Granges represented at this time.
- 11. 6<sup>th</sup> Degree Committee John Master, Venango County; Mazie Master, Venango County.
- 12. A motion was made to accept the official program of the 144<sup>th</sup> Pennsylvania State Grange Session, motion carried.
- 13. President Downey appointed Wayne Campbell and Cassidy Cheddar as Session Parliamentarians.
- 14. President Downey presented the highlights from her Annual President's Address. It was accepted and the full report will appear in the *Journal of Proceedings*.
- 15. Sister Campbell, State Grange Secretary, presented highlights from her report. It was accepted and the full report will appear in the *Journal of Proceedings*.

- 16. Chairperson Glenn Gross of the Good of the Order Committee —-The Good of the Order Committee's By-Laws-change resolutions were read for your information; they will be acted upon on Saturday, it is required that there is a 24 hours' notice before they can be acted upon. The Resolutions requiring the 24 hour notice are Resolution #42; 51; 48; and 49.
- 17. Brother Richard Mangel, Chair of the Grange Foundation Committee, presented the Foundation report. It was accepted and will appear in the *Journal of Proceedings*.
- 18. Brother Douglas Bonsall, Chair of the History Committee reported Historical work has been identified in four major areas and assigned to separate task forces. The four task forces are Archives; Written and Oral History; State Grange Museum and Finance. The report was accepted and will appear in the *Journal of Proceedings*.
- 19. Sister Barbara Gross presented her report on the Pennsylvania Grange Heritage Quilt Trail program. The report was accepted and will appear in the *Journal of Proceedings*.
- 20. Brother Vince Phillips, Legislative Director gave a report on the legislative work of the Grange. He feels that part of his work is to inform the Grange of what is going on in Harrisburg.
- 21. Brother Seidel, State Grange Treasurer, presented his report. His report was accepted and will appear in the *Journal of Proceedings*. He then presented the budget for information only, the budget will be voted on at Saturday's session.
- 22. Door Prizes were given by the Host Committee.
- 23. Session recessed for lunch at 12:05 PM.
- 24. President Downey called session back to order at 1:30 PM.

Sister Nauss talked about growing up in a Grange that is extremely supportive of our Youth. Youth are our future, sometimes we fail to realize the truth of this statement. Today's Juniors and Youth will carry our Grange into the next decade. However, our Youth are not only our future but they are our present. We need to keep our Youth members and continue to work on adding more. Show these young members that you value them as

members of our organization, elect them to an office, ask them to plan an activity or join a committee. Listen to them when they speak up. When in doubt ask the youth what they are looking for in an organization. Make the choice to invest in our youth now so that the Grange we love will be here and thriving in the future.

Be strong and courageous. Do not be afraid; do not be discouraged, for the LORD your God will be with you wherever you go."

#### PRESIDENT'S ADDRESS

President Report to the Delegate Body, State Session 2016, from Elizabeth "Beth" Downey, Worthy National Grange Ceres Claire Logan and the First Gentleman Steve, Pennsylvania Secretary of Agriculture Russell Redding, Worthy Past State Master Carl Meiss, Pennsylvania State Grange Officers, Brother and Sister Delegates, staff and guests, welcome to Shippensburg University, located in Shippensburg, Pennsylvania, the second oldest city in our state west of the mighty Susquehanna River.

Where did the past year go? Some days it feels like life is a merry-go-round in fast gear with no stops.

It is a pleasure to update you on the status of the Pennsylvania State Grange. While we are still resolving some Community and Pomona Grange problems, I am pleased to report that this year we have closed

some smaller Granges and consolidated them into other small Granges to create larger more vibrant Granges. Some of you may question my word "pleased." It is often better to combine two small Granges into one. Those of you who have consolidated will have increased opportunities by virtue of your increased numbers. You must work together to accomplish great things in your community through service to others. That is also a pathway to many to join you and become part of your excitement. I look forward to seeing your resolutions next year as you recognize needs in your community and state and to your annual reports that will tell of the great things you did in 2017. Most important, welcome each other to your new Grange and become one. Have a celebration, welcoming ceremony or community open house to begin anew as a consolidation. Remember those words, "For the good of the Order" in all things.

To those of you with small membership, we continue to implore you to increase your numbers. Your Membership Director Stacy Ebersole Bruker was very busy this past year. She not only conducted a series of membership workshops but she put a lot of miles on her car visiting many of your Granges. We cannot gain members for you. We do have the ability to teach you how to gain your members. One of the tools often used in my own area is a door-to-door day in your community. It works best with two of you greeting folks, perhaps having a little treat to pass out like a jar of jam made by members of the Grange. Tell them about your Grange and provide handouts Stacy has available. Invite them to come visit your Grange. Don't apply pressure to join but open your doors to their visits to "check you out." Always keep your doors open looking out and not closed and looking inward.

A couple more things are prudent to say about your Grange facility. Many Granges are functioning without their own building and doing well. However, to those of you who do have a building, I'd like to make some suggestions. The building exterior defines a first impression of who you are. Put a fresh coat of paint on the building. Use a pressure washer on the aluminum siding. Plant some flowers near the front entrance or place pots of flowers on the front porch along with a bench. If you do not have a flag, consider it, you may be surprised at the positive reaction of your community. You <u>must</u> have a sign on or beside your Grange identifying who you are! Most important of all, place a sign on your facility that names contact members for rental purposes and meeting information welcoming all. You never know when someone desiring to use the facility for a baby shower or family reunion may wish to join your Grange.

Last year I spoke of the interpersonal relationships of members at too many Granges being contentious and very un-Grange like. It occurred to me that since we have not had officers training for many years, we may have officers with no idea what to do in their positions. I wrote an officers manual for Community and Pomona Granges and offered four training sessions in conjunction with membership workshops by Stacy. Unfortunately, we had to cancel two of those due to lack of interest. That was difficult since we knew the training was vital and necessary. However, if you ask anyone who attended those held at Eagle Grange #1 in Lycoming County and Hayfield Grange #800 in Crawford County, attendees not only left with the new manual but will be quick to tell you how productive and educational the training was. We have some ideas you provided to try in 2017 that involve visiting 3 or 4 Pomona's at a time to conduct training. Every one of us needs to know the duties and responsibilities of the offices to conduct them properly and to not interfere in another officer's duties.

Let's take a couple moments to look at some very positive things from the past year. We have two new Granges up and running. They are Log Cabin Grange in Mercer and PSU Grange on the PSU campus in Centre County. Thanks to Cassidy Cheddar and a board of Grange mentors overseeing the young campus members, they are a very enthusiastic group doing lots of fund raisers and various events to acquire new ongoing members. Log Cabin Grange has been very busy with many community involved activities. We reorganized two Granges (Sanborn and Girard) and there were many consolidations vs. closing of Granges this past year. The picture on Granges up to date with dues payments is the best ever in

Pennsylvania. Stacy will be giving you very positive statistics on our current membership vs. a year ago in her comments at the All Granger Banquet on Sunday.

There is now an inventory list of items from Granges around the state that are available to others. The list changes often and sometimes an item listed has already been passed on so it's been a rather fluid program but you are welcome to call the office for what we think if the current list! It is up to the interested Grange to make arrangements to get the item and work with the other Grange on whether the item is free or at a charge.

New brochures were designed that have a professional look to them and are awaiting your request! These are great tools to inform others of Grange and acquire membership.

The History/Museum Committee under the chairmanship of Doug Bonsall has been revised. I am excited as the committee continues the process Mary Sproat began. We have begun collecting Grange memorabilia from all over the state hoping Pennsylvania will have a museum someday.

It has been a pleasure to testify many times this past year on behalf of our Grange membership, both verbally and in the written format. I have done so on pipelines, Sunday hunting, natural gas production, health issues and many other issues of concern to you.

Another extremely delightful event was the activities of Hayfield Grange in Crawford County celebrating their 100<sup>th</sup> anniversary. Program Director David Hay was pure genius. He had four meetings prior to the anniversary celebration at four of the founding fathers farms. It was a blessing to be at the one farm and meet the owners and participate in the program. Two weeks later we celebrated the actual event at the Grange with lots of pomp and circumstance!

Mentoring continues to be a favorite topic of mine. I am constantly asking you to be sure to mentor new members. It is such an important technique and one that takes little time. Call the new member you have been assigned and ask how he/she is doing. That takes five minutes, or more depending on how much you enjoy talking about the weather, a local issue and Grange. Call the day before a meeting to be sure the member has transportation to the meeting. And, please have a greeter whose job is delightful – greeting people as they come into your facility! Hand out an individually wrapped piece of hard candy like a life saver!!

How many of your Granges or Program Directors/Lecturers have invited an Advocate, State Officer, Legislative and Membership Directors or Youth Royalty to visit and speak this past year? These members want to see you, answer your questions and provide information to you. Please call them. If you need contact information, call the office and we will give it to you immediately.

It has seemed this past year as though a lot of prior Community Grange issues have settled down a bit. This coming year I would like to see a greater emphasis on our Pomona Granges and more participation by the representative Community Granges in their Pomona meetings and activities. This is a wonderful opportunity for camaraderie of members working together for the good of all within the Pomona. Have a farm-city day and invite other organizations to participate with you. Other than teaching attendees where their food comes from, how about providing an ambulance and organizations to discuss health issues, like the very critical heroin and opioid issues. Ask your County Commissioners and legislators to come and do a town hall meeting. How about PSU Cooperative Extension's presence to discuss proper preservation of food as we enjoy an uptick of home canning and freezing. Don't forget to invite school personnel to explain new education guidelines teachers must follow and how it affects their teaching your children and grandchildren. "Nothing given, nothing gained."

Speaking of an uptick in home gardens and preservation of food, this is a group that is just perfect for Grange. In my days we were called, "Back to the Earthers." Today this is a viable and strong group of consumers who want to be sure they are consuming healthy food and most important, they want to know the source of their food. **Get them in your Grange** and have programs of interest to them: Master Gardeners, PSU Cooperative Extension, Garden Clubs, etc. Grange was made for these folks and they will have a thing or two to teach you, as well! Perhaps we need to think about cooperatives again that sell the food we produce.

It is so important to be pro-active in your community. Many Granges are establishing libraries. Place a box on a pedestal sunk in the ground. In the box place some books which can be removed, read and returned. You may be shocked how quickly your library expands as folks donate books! Attend your school board meetings. Education is being challenged in all ways and you need to be involved. Attend your county commissioners meetings; if you wish to be on the agenda, call ahead of time. Find out what issues they are working on. Go to your township meetings and volunteer to help.

Recently I was invited as your representative to attend the White House Forum on Rural Affairs at PSU. While I was not happy to learn in an announcement by US Sec of Ag Tom Vilsack that Pennsylvania was not among those states selected to share in billions of dollars for rural assistance on various issues, it was an interesting and educational event. Some comments were made that have been on my mind for some time.

- 1.) Broadband access is not a technical issue but an equity issue enabling all citizens, rural and urban, the same opportunities.
- 2.) More future farmers will be migrants. 78% of all farmers are young and inexperienced. Those who take on farming after college have enormous student loan debts.
- 3.) Farming is the basis of all occupations in that it releases people to be free to be lawyers, teachers, etc.

Thank you! Again, I ask myself, "Where do I begin?" We have an amazing staff in the office and out in the field, so to speak. Office Manager Sandy Herman left to pursue other challenges but she was available to help her incoming replacement, Jennifer Stewart. Jen was welcomed by Sandy to call anytime and was always very gracious to Jen. It was a smooth transition with Stacy also assisting Jen. She is delightful, professional and has a spirit that has made the office environment a joy. As previously mentioned, Stacy continues as our Public Relations and Membership Director. Stacy has impressive graphic and design skills and enjoys doing the needed signage for Farm Show, Ag Progress Days, and the many other events she covers promoting Grange. We just made one major change and that is to outsource our magazine for publication. We will retain full control over the magazine contents.

In addition to welcoming Jennifer, we had the great pleasure to hire Vince Phillips as our Legislative Director. Vince had been working on an as-needed basis for several months but we wanted and needed someone to take over all legislative work. I was doing my own work plus that of a legislative director and it became far too much even though I love legislative endeavors. Vince has been absolutely outstanding since coming on board September 1. He has been doing legislative work for many, many years and excels at it. He certainly knows his way around the Capitol along with everyone working within. They all know and have great respect for Vince. I am delighted that Vince is skilled to recognize when I specifically need to testify before a committee or when he should do so. We have similar work addictions. Please feel free to email or call Vince with any legislative issues you may have. He would be delighted to speak with you and to speak at your legislative banquets this next year. In particular, he is looking for members to serve on various legislative committees around the state.

We also have the best computer person in the world. Thank you to John McDonald. His services to us are efficient, timely and done in a delightful manner. Because of John, we are able to log into the office and work from home or a hotel room.

We are all indebted to Betsy Huber for the legislative work she did for us after her election to President/Master of National Grange last year. Many of you are not aware that she was not only learning the duties of her new position but was still doing our legislative work until January 1. She forwarded to National Grange those resolutions we considered and passed which we felt were of national concern. She wrote the 2016 Legislative Policy Manual for Pennsylvania before heading to D.C.

#### REPORT OF TREASURER

Worthy State Master, National and State Officers, Delegates and Members of the Pennsylvania State Grange, it is a pleasure to bring you greetings from the office of Treasurer at this 144th Annual Session of the Pennsylvania State Grange.

Today, we are reviewing the financial records for the fiscal year ending June 30, 2016. My records, as well as the records of the Department Heads and State Office were forwarded to the firm of Hamilton & Musser, P.C. in Mechanicsburg. The audit was performed under the direction of Whitney Kohler.

As your Treasurer, I am responsible for keeping the financial records of the following accounts: the Scholarship Funds including the Leonard Rhone Grant, Ellis M. Santee Loans, Foundation Scholarships and Jonathan Sattazahn Camp Scholarships, Subordinate Grange Trust Funds (for both Active and Closed Granges), Subordinate Grange Improvement Loans, Lifetime Membership, Property Account, Emergency Fund and a portion of the general assets of the Pennsylvania State Grange.

Jennifer Stewart, our new Office Manager, took over the duties previously handled by Sandy Herman. They both worked under the guidance or our Worthy Master, to manage the day to day financial requirements of the State Office.

#### **Scholarship** Funds:

During the fiscal year ending June 30, 2016, no grants were awarded from the Leonard Rhone Scholarship Fund. These grants are available to Grange members in good standing. The student must attend Penn State and preference is given to those who pursue the study of agriculture or home economics (known today as Human Development and Family Services).

There were four (4) loans of \$750 and two (2) loans of \$500 made during the past fiscal year from the Ellis M. Santee trust. The late Ellis M. Santee, a country doctor from Shickshinny and an active Grange member, established the Santee Student Loan program. This student loan is available to members of the Grange or children of Grange members. The Santee Loan program operates on the interest earned on the investments and is administered by Wells Fargo. These loans are to be repaid within three (3) years of graduating from or leaving school and are interest free. The program depends on the student's repayment of the loans to ensure continuation of the program.

During the fiscal year ending June 30, 2016, there were thirty-five (35) students involved in the program. Three (3) students were new to the program and five (5) students completed the repayment of their loan during the year. Three (3) are making payments and the balance are either still in school or behind on their payments.

Applications are available from the State Treasurer and the State Grange Office and can be downloaded from the Pennsylvania State Grange website, <a href="www.pagrange.org">www.pagrange.org</a>. This is one of our benefits that continues to be promoted to help add and retain younger members.

#### **Subordinate Grange/Pomona Grange Trusts:**

These are funds received by Subordinate and Pomona Granges from the sale of Grange real estate. The National Grange Digest requires that these funds are to be held in trust and invested by the State Grange with no less than 90% of the interest being returned to the Subordinate or Pomona Grange every six (6) months, as long as the Subordinate or Pomona Grange remains active. The Pennsylvania State Grange returns 97%. During the fiscal year ending June 30, 2016, there were 105 Granges with invested funds. Thirty-Three (33) of those Granges are closed and eight (8) had their assets transferred to the State Grange after having been closed for seven (7) years. Three (3) closed Granges added funds to the trust for the first time. Four (4) Granges transitioned from active to closed status.

#### **Subordinate Grange Improvement Loans:**

During the past year, the State Grange Master and Executive Committee continued the program of loaning funds to Subordinate Granges desiring to make improvements to their Grange properties. These funds are from the Subordinate Grange Trust funds from the sale of Granges who have surrendered their charters. These funds must be held in trust for seven (7) years in the event the Subordinate Grange would reorganize. This program invests Grange dollars back into Grange improvements. One (1) new loan was approved during the fiscal year ending June 30, 2016. There were four (4) Granges with loans in the program. Granges interested in utilizing this program must submit an application to the State Office for approval by the State Grange Master and State Grange Executive Committee.

#### **Lifetime Members:**

As of June 30, 2016, there have been a total of 1,589 members who have become lifetime members since the program's inception in 1984. We gained 17 new lifetime members during the Grange fiscal year. In addition to permitting individuals to make an investment in their Grange future, it also provides an opportunity for Granges to honor special members by paying all or part of the lifetime fees. Occasionally, members may give a lifetime membership as a gift to family members.

In closing, I thank you for your trust and confidence. The Executive Committee and I continue to deal with low interest rates that limit the return on investment for all of the assets of the PA State Grange, the Active & Closed Granges and the Grant and Scholarship Funds. I will continue to keep the best interest of the Grange and its membership in mind when considering future conservative investment options.

### REPORT OF THE PA STATE GRANGE FOUNDATION

In 1994, at the State Session in Warren, Pa. the Pennsylvania State Grange Foundation was formed by delegate action. Officers for 2015-16 are: Chairman, Richard Mangel; Secretary, Bob Bair; and Treasurer, Henry Seidel. The main purpose of the Foundation is to house two Grange scholarship funds established by the delegate action.

The Deaf & Community Service Department and the PA State Grange Executive Committee oversee the Sign Language Training Program scholarship Fund, from which a grant of \$250 is available each year. There were no applicants this year for this scholarship. The balance of this fund as of June 30, 2016 is \$1,531.94.

The Grange Scholarship Fund provides for grants to be given to Grange members in their junior or senior years at an institution of higher learning, for any course of study, according to the resolution of 1996. The Executive Committee administers the fund. A scholarship committee comprised of the State Overseer, one Executive Committee member, and three Grange members, at least one of whom is an educator, select the grantees. The balance in this fund as of June 30, 2016 is \$78,358.27. These funds are invested by the State Grange Treasurer. Only the interest may be used for scholarships each year. This past year a Museum account was opened within the foundation which is to house any monies given for the future purpose of possibly establishing a Grange Museum. As of June 30, 2016 there is \$233.03 in this account.

The total amount within the Pa State Grange Foundation Scholarship fund as of June 30, 2016 is \$80,123.24 which includes the Sign Language Fund, the Museum account, and the Grange Scholarship fund.

Also within the funds of the Foundation is the Jonathan Sattazahn Camp Fund. The purpose of this fund is to enable more children and youth to attend the PA State Grange Junior and Youth Camps. The balance of this fund as of June 30, 2016 is \$15,442.21.

The winners of this year's scholarships were Kyle Boose of Valley Grange #1360 in York County, Tana Rine of Marion Grange #223 in Centre County, Halee Wasson of Victor Grange #159 in Centre County, and Heather Wasson of Victor Grange #159 in Centre County. Congratulations to our fellow grangers.

The greater the principal, the more grants we are able to give to our young adults. One way to contribute is through the State Officers project held at State Session each year. Another way to contribute is by sending a personal check or Grange check to the State Office, marked "Grange Foundation Donation". Any amount is welcome and will be put to good use. We strongly encourage all Granges and members to consider donating to the fund now, or leaving a bequest in your will to the Grange Foundation.

Thank you for your support of this extremely important and worthwhile endeavor that enhances the educational opportunities for all our members, regardless of their course of study or choice of institution.

#### REPORT OF THE HISTORY COMMITTEE

After serving as chair of the State Grange History Committee for many years, Mary Sproat asked to be replaced in mid-2016. Douglas Bonsall, a member of the History Committee, was appointed as the new chair and several brainstorming sessions were held with the State President to get a sense of the future direction for the committee. Historical work has been identified in four major areas and assigned to separate task forces. The facilitators of each task force will form the State Grange History Committee along with the chair and the President.

An analysis was written and presented to the State Grange Executive Committee in July. Approval was received to move forward with further research in each of the following areas and recommend appropriate actions:

#### Archives – Jennifer Nauss, facilitator

The most immediate need is to develop a practical methodology for handling the large quantity of written records, photographs, disbanded Grange charters, and other Grange related artifacts currently in possession of the State Grange or stored with the State Archives of Pennsylvania. Microfilming is still the most permanent technology for preservation of records but the cost of equipment and labor is prohibitive for large quantities of material. Digital images, while possibly more accessible for users, have a limited life as the technology for storing them changes.

Among the tasks for this task force already identified:

- Define what records/artifacts should be preserved as items of historical significance
- Develop a retention schedule for records and other Grange materials
- Continue work to Inventory and catalog photographs, charters and artifacts
- Meet with officials of the State Archives of Pennsylvania to clarify current procedures and projected long-term plans for storage of Grange records
- Investigate the feasibility of seeking to have Grange records converted to an electronic media that
  would preserve the material indefinitely and also provide easier access to the information by
  interested parties
- Determine if it is in the long-term best interests of the Grange to continue storage of records with the State Archives of PA <u>OR</u> if the Grange should seek to develop/maintain its own climate-

- controlled records storage area, either incorporated into a proposed State Grange Museum or in another appropriate facility
- Continue to encourage active Granges and especially those becoming dormant to submit records for long-term preservation to whatever facility is determined to be the best depository for this material

It was during Sister Sproat's tenure that some records from the State Grange as well as those from nearly 200 Subordinate and Pomona Grangers, both active and disbanded, were deposited for safe keeping with the State Archives of Pennsylvania in Harrisburg. Currently, the State Archives facility holds 170 cubic feet of Pennsylvania Grange records in Manuscript Group 493, the largest amount in original paper form and a smaller amount of microfilmed records. Initially, Grange records were accepted on a temporary loan basis, microfilmed by the State Archives and the originals returned to the owner.

Two representatives of the State Grange had a very informative and productive meeting on 9/2/2016 with Mr. Joshua Stahlman of the State Archives. He confirmed that the State Archives will no longer microfilm records submitted to them and the acceptance of paper records for permanent storage is now subject to review/approval by a committee of this agency. We have requested and are waiting on a specific list of the types of records that are most likely to be accepted by this review committee. When that information becomes available, it will be distributed so Granges wishing to submit records to the PA State Archives can prepare a detailed listing of those records for consideration before actually delivering them. Records accepted for storage by the State Archives will require Granges to sign a form permanently transferring ownership of the records to the State Archives. The State Archives is open to the public so Grange members are able to visit and view stored records if they wish.

#### Written & Oral History – Bill Steel, facilitator

The duties of this task force may include the following initiatives:

- Write an abbreviated history of the Pennsylvania State Grange, perhaps in an easy-to-read bulleted chronology, for immediate posting to the Grange website as the current history tab on that site includes very limited information on PA Grange history.
- Make available the electronic data base, capable of being sorted, of all Granges ever chartered in Pennsylvania so researchers can access name, number, county, current status and other significant historical facts
- Determine what other historical information and in what format can reasonably be included on the State Grange website
- Explore the advisability of recording an oral history in audio and/or video format to capture more of the "people" aspect of the Grange while these persons are available for interviews
- Provide regular historical tidbits for inclusion in the Grange News publication as a means to share information and enhance pride in the historical accomplishments of the Grange
- Pursue the publication of a volume covering the history of the Pennsylvania State Grange from 1998 through the celebration of the 150<sup>th</sup> anniversary in 2022, including the best method to print, market and distribute the publication

#### **State Grange Museum** –*Still searching for facilitator*

From time to time over a number of years there has been some interest expressed for the creation of a State Grange Museum to exhibit the history of the organization to the members and to the public. Perhaps the strongest interest for a PA Grange Museum has been shown at Eagle Grange #1, Lycoming County, where some preliminary investigation has been done with the Lycoming County Historical Society and other local groups. The chair met with members of Eagle Grange in August to discuss the project but their limited resources of people and money make this undertaking unfeasible without much assistance from outside sources.

Eagle Grange Hall is a historic two-story building of frame construction surrounded by approximately 5 acres of land and is highly visible to the public due to its location immediately adjacent to Route 15 about seven miles south of Williamsport. The hall does not currently have an elevator to provide handicap access to the second floor, nor does the facility have climate controlled features that a museum housing fragile historical artifacts and written documents would require for their long-term preservation. A large investment would be necessary to convert the facility to a museum.

Establishing a museum would, in addition to funding, require considerable amounts of labor and would likely benefit from assistance from professional museum curators. Many of the historical artifacts currently being stored at the State Grange headquarters would logically form the basis of the display collections and it could reasonably be anticipated that donations of many other items would be made by local Granges and individuals. Depending upon the recommendations of the Archives Task Force, a potential component in a museum may be the inclusion of a climate-controlled storage facility for Grange records if the determination is made that the permanent transfer of Grange records to the State Archives is not acceptable.

The long-term success and on-going viability of a State Grange Museum would depend on changing displays to encourage repeat visits and the establishment of a hands-on educational outreach program geared to attract the general public, especially school groups and families. Many community museums have staff educators, either paid or volunteer, who lead workshops to teach both history and useful skills to visitors. A common term for this is "living history". With its rural and agricultural background, a PA Grange Museum could become an attractive destination for visitors if workshops/demonstrations on agricultural, environmental and traditional artisan skills could be developed and taught.

#### **Finance -** Anna May Nauss, facilitator

The considerable challenges facing the State Grange History Committee are obvious, not the least of which is finding financial resources to proceed. Each of the three above mentioned task forces will require funds for implementation of any specific projects undertaken. Perhaps almost equally important as the initial fund raising is the creation of on-going sources of financial support for the long-term. Therefore, the creation of a task force specifically charged with the raising of adequate funds to allow historical projects to proceed is vital.

The Finance Task Force will likely begin its deliberations a bit later than the other task forces. The Archives, Written & Oral History and Grange Museum Task Forces will begin work first to develop detailed action plans for their projects, setting short-term (1-2 years), mid-term (3-5 years) and long term (6 or more years) priorities with as much of the financial requirements of each phase as possible. As these more specific funding requirements can be determined by each task force, then the Finance Task Force will explore the various and unique ways by which funding can be secured for each initiative.

Some volunteers have already indicated their interest in serving on one of the task forces but more volunteers are needed. Most importantly, a skilled and energetic facilitator for the Grange Museum task force is needed if the first step – *that of initial investigation* – is to be undertaken. If this important position cannot be filled, the Museum proposal will be dropped from the History Committee's agenda and efforts will be focused on the other identified areas.

# REPORT OF THE LEGISLATIVE DIRECTOR

The Pennsylvania State Grange has strengthened its legislative/advocacy efforts. First, there were staff changes with Betsy Huber being selected as President of the National Grange. She was replaced by veteran lobbyist Vince Phillips who monitored legislation for the PA State Grange until his formal designation as Legislative Director September 1, 2016. Highlights of activity include

#### TESTIMONY/ADVOCACY

- PA State Grange President testified on Sunday hunting ban before Senate Game & Fisheries Committee
- Correcting loophole in law which exempts farmers (in farmland preservation) from Real Estate
  Transfer Tax. Loophole allowed for retroactive tax collection asked to help on this by PA
  Department of Agriculture
- Support of House resolution urging use of science-based research in making public policy decisions
- Written testimony to House Consumer Affairs Committee on Broadband access for rural Pennsylvanians and continued access to land lines (two hearings)

- Wrote PA Department of Labor & Industry regarding agricultural jobs as High Priority
  Occupations (an enabler for workforce development funding) at request of PA Department of
  Agriculture
- Set up legislative appointments for PA State Grange Family Day on Capitol Hill
- Individual conversations with legislators such as Rep. Ed Neilson re property tax exemptions for Grange Halls, opioid/heroin crisis with Senator John Wozniak and Senator Gene Yaw
- Drafted testimony from PA State Grange President on affordability of long-term care insurance to PA Insurance Department

#### REPORT OF THE MEMBERSHIP DIRECTOR

Worthy President, State Officers, Honored Guests and Delegates;

It continues to amaze me that the Grange is its own best kept secret. We've all gotten so much out of this organization, whether you've been a member for 5 or 50 years, and it's about time we start sharing all it is we have to offer.

As your Communications/Membership Director, it's my job to inspire, encourage and prepare you to turn those potential members into active members. I can lead workshops, provide resources and materials, encourage members, set up promotional exhibits, and answer questions. What I can't do is go into your community and sign up members for your Grange. That is the job of each and every one of you as a member of the Grange, to make sure that there is a Grange for future generations. Wouldn't it be a shame for people to miss out on all the great stuff that we've had the opportunity to experience as Grange members?

So think about your Grange, the regular monthly meeting, is this an experience that you want to share with others? Or is there bickering and shouting, disorganization and no one to take charge of anything? This is where you need to start your membership recruitment efforts, making your Grange a place you want to share with others, an atmosphere that is welcoming to members and potential members alike.

Those who attended one of our Membership/Leadership workshops learned how important it is to treat your new members well, like GOLD even. They are the future of our Grange, and it doesn't matter how old they are, they are the future of this organization. These workshops included officer training and a focus on member retention. In focusing on the retention of current members and not the recruitment of new members, we shift the focus to our Grange and its current members, and what we're doing that's driving people away. (And yes, it's happening everywhere, not just in your Grange.)

Each year we initiate into our Order hundreds of new members, and yet our membership totals continue to decline. Why is this? It's not because members are passing away to that Great Grange Above. Yes, that happens, but as we learned last year, about 75% of our members leave voluntarily, not because they passed away. They leave because their ideas weren't heard, because they were shut down when trying to volunteer, because they're tired of the bickering and fighting every month, because they were treated poorly by that member that everyone else "just deals with". All these reasons are at the lead back to what's keeping our Granges from growing, our own members. It's time to take a stand for your Grange, take on a leadership role, or take it away from the person who treats others poorly. I've heard from quite a few Grangers that complain about the current state of their Grange but aren't willing to do anything to change the status quo – if you aren't part of the solution, you're part of the problem.

The Membership/Leadership workshops weren't as well attended as we had hoped they would be, in fact, two of them were cancelled due to lack of interest. Those who did attend (about 40 people between two workshops) received some great information and resources to help grow their Grange and the future leaders of their Grange.

In addition to these workshops, I've been working hard to make additional improvements to the work we do at the State Office and the resource we have available to all of you. We now have new brochures, recently redesigned with the help of Allegra-Harrisburg, the same company that conducted our membership survey last year. They were invaluable in that process, are familiar with our organization and what we are trying to accomplish as a result of the survey results. The new brochures focus on the social aspects of the Grange, which we learned is the main reason that people join the Grange. These brochures are available to all Granges FREE OF CHARGE! So be sure to request these updated brochures for your next event.

I'm proud to report that this year we've reorganized two Granges and chartered a new one. Girard Grange #788 and Sanborn #2016, both in Clearfield County successfully reorganized. In Mercer County, we chartered Log Cabin Unity Grange #2110 in early 2016. All three of these Granges continue to be active in their communities and are growing. So it's possible for your Grange to grow, no matter how many members you currently have 5, 25 or 50, your Grange has the potential to GROW. As your Membership Director, I'm ready, willing and excited to visit your Grange, promote membership and get your members excited about the potential in your Grange and the community!

As I've been out visiting Granges, I continue to remind members that their Grange didn't lose their members overnight and they won't gain them overnight either. Growing your Grange is a process, but one that you must start now, not next month or next year. A membership plan should be part of your annual planning meeting each year. How are you going to turn all those great events that your Grange already hosts into membership recruitment opportunities?

As for the membership promotion at the State Grange, we again hosted booths at both the Pennsylvania State Farm Show and Ag Progress Days. These two events are invaluable public relations opportunities. The staff and volunteers that work during these events promote all the local Granges, and gather membership leads from people who are interested in learning more about the Grange in their home town. We pass the contact information on to the local Grange, asking that you follow up with the prospective member to invite them to your events and regular meeting. We are in need of people to help with these promotions. The Farm Show runs 8 days now, and it's just not possible for 3 staff people to cover the booth for all those hours. We need your help to make sure the Grange continues to have a presence at the Farm Show.

Now, for the numbers... As of the end of the second quarter (June 30 2016) the Pennsylvania State Grange has 6,941 members, which does represent a decrease in the number of members we had at this

time last year. But you know what's great about this number – it's less of a decrease than we've experienced in previous years. We are moving in the right direction, before we can talk about significant gains, we have to decrease out losses.

Our Granges welcomed 257 new members during this membership year, which is from July 1, 2015 through June 30, 2016. These new members came from the efforts of just 56 of our local Granges. Congratulations to those Grange that welcomed new members, they will be recognized at the All Grange Banquet on Sunday afternoon. The bad news is that we have a total of 211 Grange in Pennsylvania, so there were 155 Granges with no new members. Imagine the potential if each of these Grange took in just one new member!

Another piece of good news – our NET change in membership was the smallest it's been in about 2 years. (The NET loss or gain in membership factors both the members gained and the members lost.) We had a NET loss of just 28 members in the 2<sup>nd</sup> quarter of 2016. Some may look at this in a negative light; after all, it's still a loss in membership. I look at it as a great achievement, because we are finally moving in the right direction, losing less members each year brings us closing to realizing a gain in membership.

Our challenge for the 2016-17 membership year is to achieve a NET Gain in membership, and I know we can do it, because we've done it in individual quarters before, now it's time to maintain the momentum and develop a plan for your Grange – How are you going to contribute to the gain in membership for 2017?

# REPORT FOR THE PA GRANGE HERITAGE QUILT TRAIL COMMITTEE

The PA Grange Heritage Quilt Trail is now in its seventh year and still going strong. There are over 100 blocks now mounted in PA on Granges, Fairgrounds and community buildings along with the PA Grange Heritage Quilt Trail <a href="www.pagrange.org">www.pagrange.org</a> sign. Through *Paint Your Own Quilt Block Workshops* we now have close to 200 people experienced in planning and painting quilt blocks.

Classes have been held for Grangers, Quilt Guilds, Art Councils, community organizations and individuals during the year with at least 40 new blocks having been painted. Once again the *Paint Your Own Quilt Block Workshop* was held at Family Fest, with 17 Grangers painting quilt blocks.

Thanks to retired Penn State Journalism professor, R Thomas Berner, short articles along with photos about the PA Grange *Paint Your Own Quilt Block Workshop* were published in the <u>Grit magazines</u> May/June and July/August issues. As a result of the article, inquiries about painting barn quilts have come in from as far away as Louisiana, Michigan and Connecticut. The "Paint Your Own Quilt Block" workshop was also highlighted in Mr. Berner's book, <u>Pennsylvania Quilt Barns</u>, The book includes photos of Grangers painting quilt blocks and three barns with quilt blocks painted by Grangers or people who attended a Grange sponsored workshops.

Our pagrange.org website has been updated this year and we have a new Quilt Trail link. It features a map pinpointing the physical location and address of the PA Grange Heritage Quilt Blocks of which we have information and photos. If you have a mounted Quilt Block(s) that is not on the new web site please fill out the form provided on line and send in a photo – either by e-mail or snail mail. Or if you wish to update your present photo with a new photo please call the PA State Grange office or one of the persons listed below and we will work with you to get it posted.

In order to get more aesthetically pleasing photos of our Quilt Blocks to place on our web-site, the PA Grange Heritage Quilt Trail Committee has sponsored a contest at State Session that will offer monetary rewards for the top five Quilt Block photographs that have the pagrange.org sign included in the photo.

## REPORT OF AGRICULTURAL AND ENVIRONMENTAL ISSUES COMMITTEE

Worthy Master, State Officers, Delegates, Distinguished Guests, Brothers and Sisters:

The members of Agricultural and Environmental Issues committee are again honored to serve the members of the Pennsylvania State Grange. We have reviewed the resolutions presented to our committee with an open discussion and have presented them in a way that we feel best addresses these issues.

The committee has also introduced resolutions for Grange approval.

Agriculture's impact on the Environment is under constant attack by environmentalist. Agricultural producers and the Grange must take a proactive position to maintain a profitable balance while creating a sustainable environment. The Grange supports negotiating trade agreements that recognize the importance of and the global nature of Agriculture. These Pacts should level the playing field, expand our markets, and help stabilize needed supplies.

Pennsylvania Dairy farmers are presently encountering economic hardships. The Pennsylvania State Grange is in support of the Dairy Transparency Bill that will show how over order premiums are distributed. Present Grange policy is for distribution to all PA producers.

Dairy, Confinement Livestock and Poultry operations are facing water usage limitations or usage fees. Grange has presented policy to oppose any regulation or usage fees imposed on agriculture and privately owned residential wells.

As the Clean Water Act is being implemented Grange continues efforts to counter the expansion of the EPA's jurisdiction.

Pennsylvania farmers are suffering economic losses from an overabundance of wildlife thru crop damage or Predatory species such as Coyotes. Grange is encouraging the Game Commission, PA Dept. of Agriculture, USDA / APHIS / Wildlife Services to implement measures to manage this wildlife population.

# \* Animal & Plant Health Inspection Services

The Grange has limited representation at agricultural fairs thru out the state of Pennsylvania for Junior Grange projects.

The PA. State Grange has taken an initiative to have more presence and opportunities for Junior Grangers to compete and participate by petitioning the Fair boards in areas where a JR. Grange is active.

The Grange extends congratulations to the Tree Farm System that is celebrating its 75th anniversary this year. This group was years ahead of their time in restoring forests and sustainably managing woodland resources. Their product has gained value as it is now recognized as a sustainable source for those who wish to gain green certification such as *LEED*.

## \* Leading Energy Efficient Design

The Grange supports the Congressional clarification of treatment of "Electronic Sales of Livestock Act' that insures electronic sales and banking are covered by the Packers and Stockyards Act of 1921.

This year, the focus in our policy statement is on two issues: long-term care and the opioid and heroin crisis.

Long-term care is a personal responsibility that should not be ignored. It is needed when someone is unable to perform basic self-care tasks (such as bathing, dressing, or eating) and/or is unable to perform instrumental activities of daily living (such as household chores, meal preparation, or managing money). Long-term care may be home-based and provided by unpaid individuals (such as family members). It may be home-based but with paid assistance. It may be community based, such as in an assisted living facility, or it may be institutionalized assistance, as in a nursing home. According to the U.S. Department of Health and Human Services (2015), 70% of people over age 65 will need one of the above forms of long-term care.

Long-term care is also a very expensive responsibility. Medicare does not cover extended care, and may cover only a maximum of 100 days of services per benefit period after a hospital stay. To qualify for long-term care through Medicaid, you must demonstrate financial need, which means you must deplete most of your financial resources prior to receiving benefits. As Grangers, it is in our best interest to be proactive in planning for financing our long-term care needs. Pennsylvania has an option

for long-term-care insurance, titled "Long-Term Care Partnership Policies." Act 40, signed into law in 2007, established a "Long-Term Care Partnership", which both protects consumers by requiring that all partnership long-term care insurance policies sold in the state provide comprehensive coverage, and also provides asset coverage equal to the benefits paid by the policy. For example, a person whose qualifying policy paid for \$100,000 of care would be entitled to keep \$100,000 in assets if they need to apply for Medical Assistance in the future. Act 40 also gives consumers, in some cases, the ability to exchange their existing long-term care policies for Partnership Policies. As of July, 2016, there are sixteen Partnership Approved Policy carriers in the state.

Once again, as Grangers, it is our responsibility to investigate all means of funding long-term care prior to making a decision. We need to understand self-funding, hybrid life insurance policies, long-term care policies, and partnership policies. We need to educate ourselves regarding available policies from a variety of reputable and licensed companies. We need to understand the coverage their products provide, and compare costs and benefits. We need to consider our personal risk factors, assets, income, costs, and alternatives. As a source of information, please log onto <a href="www.insurance.pa.gov">www.insurance.pa.gov</a>, look under the title "Coverage," and select "Long-Term Care." You may also call the department toll-free on their automated hotline at 1-877-881-6388.

The opioid and heroin crisis has reached epidemic proportions, according to Dr. Margaret Jarvis, the medical director at Geisinger Marworth Treatment Center. In 2015, 3,505 people in Pennsylvania died from drug overdoses—more than the number of people who died in car crashes. (Pocono Record, 9.23.2016)

According to Dr. Jarvis, it is the most significant public health crisis facing our state today. As noted by the Pennsylvania Department of Health and the Pennsylvania Medical Society, "Prescription opioid abuse has become an issue of national importance as drug overdose is the leading cause of accidental death in adults living in America."

The question arises, how did this opioid and heroin crisis happen? What is the cause? And, as in many complex issues, there is more than one answer. Opioids have been used for many years for the treatment of severe pain, often caused by trauma, surgery, extensive burns, and terminal diseases. In some cases, these opioids have been over prescribed, or patients who have become dependent on these medications have acquired prescriptions from multiple providers. Also, prescribed pain medicine is usually paid for by insurance companies. Alternative pain management therapies, such as biofeedback training, exercise programs, or meditation training are often not. Despite the good intentions of the medical community, a deadly epidemic of addiction and misuse of opioid prescription medication has occurred. Often, when prescription opioids become unavailable, patients turn to heroin, which has a similar molecular makeup and is cheaper and more readily available. Heroin also reaches the brain very quickly when injected into a vein, and so gives the user a faster high. It is true that not every opioid or heroin addict started out as a patient being treated for chronic pain. Some have chosen that path through experimentation—finding medications left carelessly around the house, or "partying" with friends.

In response to this crisis, The United States Department of Health and Human Services has announced a targeted initiative aimed at reducing prescription opioid and heroin related overdose, dependence, and death. The initiative focuses on prevention, treatment, and intervention. Healthcare professionals will receive training and educational resources to help them make informed prescribing decisions so that overprescribing of opioids can be avoided. Prescription drug monitoring programs to support data sharing for safe prescribing will be facilitated, and the development of lifesaving drugs such as naloxone will be supported.

In Pennsylvania, Governor Tom Wolf has made fighting Pennsylvania's opioid and heroin epidemic a top priority. Governor Wolf's 2016-17 budget proposal provides \$34 million to establish new treatment centers and improve treatment options for Pennsylvanians struggling with substance abuse disorder. Once established through the Department of Human Services, the proposed Opioid Use Disorder Centers of Excellence would provide medication-assisted treatment and appropriate wraparound services, such as cognitive-based therapies, for individuals in need of treatment. In addition, the Pennsylvania Department of Drug and Alcohol Programs has established several programs and initiatives to address the issue.

What can we, as Grangers, do to combat this problem? First and foremost, we need to increase our awareness of the issue and educate ourselves regarding the subject. If this problem does not directly affect us or our families, it most certainly will affect our neighbors, friends, or acquaintances. Check out <a href="www.ddap.pa.gov">www.ddap.pa.gov</a> and <a href="www.drugabuse.gov">www.drugabuse.gov</a> for more information. Read what is printed in the local newspaper to see how close to home this problem actually is. Check the prescription drugs on hand. If there are opioids among them, keep them under lock and key to both prevent children and teenagers from accessing them out of curiosity and to keep them from being stolen. If these drugs are no longer being taken, get rid of them! Keeping unused opioids or other common drugs of abuse in a medicine cabinet is no longer safe or responsible. Permanent prescription take-back boxes are available in 62 of the Commonwealth's 67 counties. Check the <a href="www.ddap.pa.gov">wwww.ddap.pa.gov</a> website to find out exactly where these take-back boxes are located and use them! The goal is to reduce the amount of prescription drugs available for potential misuse and/or abuse. Since 2015, approximately 145,857 pounds of prescription drugs have been collected and properly destroyed. Every Granger can do something to combat this problem. Let's make sure we do.

- 1. The Special Budget Meeting of the Pennsylvania State Grange officially opened in the 6th degree on Saturday, January 28, 2017 at 1:30 PM at the Logan Grange, 122 North Main Street, Pleasant Gap, PA, Centre County with President Elizabeth Downey presiding.
- 2. Roll call found Executive Committee Member Janet Pratt absent.
- 3. The Credentials Committee consisting of—Virginia Mangel, Chair, Joanne Heim and Denae Zvarick Sister Mangel gave a report of the Credential's Committee as follows:

119 Delegates and representing; 65 Subordinate Granges and

27 Delegates and representing; 16 Pomona Granges

7 Guest present

153 Total Present

- 4. Brother Seidel, State Grange Treasurer, presented the updated Proposed Budget finalized by the Executive Committee on December 9, 2016—
- 5. A motion and seconded to move for the previous question, (to vote on the budget). Motion failed.
- 6. A motion was made and seconded to recall Resolution #47 back on the floor for review. Motion carried.
- 7. A motion was made and seconded to reject Resolution #47. Motion carried. Resolution #47 is rejected. (This would reduce the Salary by \$2,000 which was approved to be in compliance with the Federal Law and to avoid paying overtime wages. Federal courts overturned this USA Department of Labor, Fair Labor Standards Act Law Act and determined it was illegal.) Motion carried.
- 8. A question was asked if anyone was able to attend an Executive Committee Meeting. It was stated that it is open except in the event of a Personnel issue. The next Executive Committee meeting will be March 23<sup>rd</sup>. The Executive Committee are looking into also using Zoom to hold meetings without the members traveling to Harrisburg to save on cost.
