MINUTES OF THE 149TH ANNUAL PA STATE GRANGE SESSION

FRIDAY, OCTOBER 15, 2021

- 1. The 149th Pennsylvania State Grange Annual Session officially opened in the Sixth Degree on Friday October 15, 2021 at 9:00 am in the Valley Forge Casino Resort, King of Prussia, PA with President Wayne Campbell presiding. There was no opening drill due to the size of the stage.
- Sister Rachel Bailey, Director of Deaf and Community Service thanked everyone for their community service as we are changing lives. The committee is collecting donations for the Good Samaritan Homeless Shelter. Sister Bailey announced the 1st place winners for the Community Service Awards. All contest winners will appear in the *Journal of Proceedings*.
- 3. Roll call found all officers present. Sister Doris Evans served as the pianist for the session.
- 4. President Campbell lowered to the Fourth Degree.
- 5. Sister Jenn Nauss presented a candle lighting service in celebration of the 150th Anniversary of the Pennsylvania State Grange with the State Officers.

Since its founding, the Grange has understood the importance of leadership skills – both in expecting the most of its current leaders to developing these skills in future leaders. The founders recognized the importance of nurturing leaders and of sharing the burden of responsibility fairly among officers.

When the time came to name the new organization, the founders decided to use a term that Oliver Hudson Kelley had read in a novel — "Grange". "Grange" referred to old English farm estate, which the founders thought was an appropriate reference for their new agricultural fraternity. When determining how to assign leadership responsibilities, they used titles and positions which were found on those old farm estates. Although officer titles have been modernized in many Granges, the leadership structure established by the founders has remained unchanged — 13 officers (plus an executive committee in many Granges). Responsibility for leading the Grange is shared by these 13 individuals who have clearly defined roles within the organization.

From the beginning, the founders realized that responsibility and power needed to be shared. They also urged that leaders take these roles seriously. In fact, the Declaration of Purposes states this in the section titled, "The Office Should Seek the Man, and Not the Man the Office". "We desire a proper equality, equity, and fairness; protection for the weak; restraint upon the strong; in short, justly distributed burdens and justly distributed power".

The Grange has long sought to instill these ideals in its members, providing leadership training to current officers, as well as to Youth and Junior members. No matter what level of the Grange, the quality of the organization relies on the quality of its leaders. True leaders do more than attend a monthly meeting and don a sash. Those most effective officers are those that lead the way – and work alongside – their members. This is no easy feat, but worth the effort. In the Secretary's charge in the 4th Degree, the secretary instructs new members, "In our fraternity there is work for all and those reap the most abundant harvest of Grange benefits who contribute most liberally of their own time and talent."

As the Grange in Pennsylvania celebrates 150 years, it is critical that officers in all Granges step forward to lead their members through the difficult waters of change – to celebrate the

achievements of the last 150 years and identify how the Grange can move forward toward the next 150 years. The accomplishments of the past are worthy of recognition, but they do not light our way to find new ways to be relevant and serve our communities. Our leaders have the potential to be that light, leading our Granges into the future – if they are up for the challenge.

As Former CEO of General Electric, Jack Welch, once said, "A leader's job is to look into the future and see the organization, not as it is, but as it should be." Let this 150th Anniversary be the fuel to spark our enthusiasm to find that light — and be that light — in our Granges.

6. Honored guests recognized were Betsy Huber, National Grange President and Past Pennsylvania State Grange President and National Grange Representative. A prerecorded recording was played at this time. President Huber encouraged everyone to attend the National Regionals. She recommends everyone attend the 154th National Grange Session in the Great Plains Region.

President Campbell called Sister Mary Jane Kent and Sister Marty Dinsmore to the stage. President Huber recognized Harveys Aleppo Grange #1444 for being a Distinguished Grange in 2019. National Grange also recognized the Kent family in the Grange Legacy Families program through six generations within the Grange.

Past State Presidents Elizabeth Downey, Carl Meiss and Past First Lady and Past National Priestess Annalist, Fae Snyder.

- 7. Brother Terry Murray, Co-Chair of the 2021 Host Committee, welcomed everyone to King of Prussia, Montgomery County, Pennsylvania. Pennsylvania State Grange Session was hosted by the South Eastern Region. Brother Murray introduced his committee. Brother Michael Adams is also a Co-Chair.
- 8. President Campbell announced the meeting will be recorded for Minutes taking purposes only.
- 9. President Campbell appointed Brother Michael Martin as Session Parliamentarian.
- 10. Sister Jodi Keith-Kensinger gave us devotions titled "Unlucky but blessed at the same time". Sister Kensinger then read the scripture Jeremiah 17:7-8 and Psalm 20:4, where we are all blessed if we look to God with our desires. We must trust God in every aspect in our lives. It's a good thing to be a Granger.
- 11. There will be a 2-minute limit on all discussions. However, for the National Headquarters discussion this may be a little more lenient.
- 12. Sixth Degree Committee Sister Denise Clare Berks County and Sister Anna Heffner Berks County.
- 13. Appointment of Session Committees—Credentials—Barbara Schroeder, Berks County, and Derek Schroeder, Berks County. Sister Schroeder gave a partial report of the Credential's Committee as follows:
 - 87 Delegates and 53 Subordinate Granges and
 - 36 Delegates and 22 Pomona Granges represented at this time.

With a total of 134 Delegates present at this time. President Campbell confirmed that we do have a quorum and can proceed with our work.

- 14. A motion was made and seconded to accept the official schedule of the 149th PA State Grange Session with corrections, motion carried.
- 15. Brother Michael Martin, Chair of the Salary Committee presented their report. Serving on the committee were, Barbara Warden, Jacob Mengel and Henry Seidel, ex officio.

A motion was made and seconded to accept the Salary report as recommended by the Salary Committee, motion carried.

- 16. President Campbell presented the highlights from his Annual President's Address discussing the purchase of the new Pennsylvania State Grange Office. It was accepted and the full report will appear in the *Journal of Proceedings*.
- 17. Brother Andrew Kieffer, State Grange Steward stated, that when you speak you must give your name, Grange and County. He also announced that you need to turn your phones to vibrate. If he hears your phone, it will cost you \$10.00.
- 18. Sister Nauss, State Grange Lecturer gave a short report and announced winners for reports and scrapbooks for the Lecturer's Department. She also introduced her committee members. All contest winners will appear in the *Journal of Proceedings*.
- 19. Brother Henry Seidel, State Grange Treasurer, presented highlights from his report. Brother Seidel referred to the letter from Hamilton and Musser stating that the review has been completed. His report was accepted and will appear in the *Journal of Proceedings*.
 - Brother Seidel then presented the budget for information only; the budget will be voted on at Saturday's session. The Budget can be voted on after 11:00 am; this will have allowed it to lay over the required 24 hours.
- 20. President Campbell introduced Secretary of Agriculture Russell Redding. He is a former Dean of the School of Agriculture and Environmental Sciences at Delaware Valley University formerly Delaware Valley College. Secretary Redding has spent more than 20 years representing Pennsylvania agriculture as a public servant in Harrisburg and Washington D.C. A native Pennsylvanian, Redding grew up on his family's dairy farm and now operates a general crop farm in Gettysburg with his family. He is a graduate of Penn State's College of Agricultural Sciences.

Secretary Redding thanked the Delegate body for all their work. We all look at things differently than we used to. He's very proud of what Agriculture did in the past year and half. Helped make people know the importance of where our food comes from and how important farmers are. Thank you to the Grange for your voice and what you do. You do have a voice!

One issue the Department of Agricultural is dealing with is deer herds, the number of deer herds in Pennsylvania have greatly increased. This increases the risk of CWD and the ability to control it more difficult.

21. Sister Jane Birk, Chair of the Good of the Order Committee presented the following resolutions because "Our State Grange Bylaws" state in paragraph 1.14.2 any proposal to amend these By-Laws shall be submitted in writing, including the recommended language for the change, and reported upon by the Committee on By-Laws one full day before being brought to the floor for a vote of the delegates.

Resolution #24 addresses changing section 1.8.1 to read 6 regions instead of the current 8 regions.

Resolution #25 addresses the description of family.

Resolution #26 addresses the Community Grange dues.

22. Sister Lizzie Bailey, Public Relations/Membership Consultant presented her report. It's been a long 15 months. Sister Bailey was stunned how the Granges prospered during the Pandemic. Power of Grangers stepped up assisting the community.

Sister Bailey was very excited with Family Festival. She had a marketing meeting. What worked in your Grange and what didn't? A Junior Granger, Elsa, attending the workshop stated she wanted more things with animals and more things with her friends.

Sister Bailey offered to come to your Grange or be on Zoom. Just reach out to her for assistance. Sister Bailey's report was accepted and will appear in the *Journal of Proceedings*.

23. Discussion on National Grange Headquarters with President Huber. National Grange has owned the building for 61 years. The building needs a lot of work. Things are not up to code. They have fixed the boiler, air conditioning, redid the conference room, but there are many more things that need to be repaired.

However, the location may not always be the best place with things that are happening at the Nations White House.

What happens if the Government uses eminent domain and just takes the building? Planning ahead with two attorneys in case the Government does use eminent domain on the location and building.

- 24. Door Prizes were given by the Host Committee.
- 25. Session recessed for lunch at 12:04 PM.
- 26. President Campbell stated that all candidates will be limited to two minutes. President Campbell then asked for suggestions for State Officers. Those suggested were:

- 27. President Campbell requested that Jennifer Beamon (Pomona), Virginia Mangel (Flora) and Hannah Leibensperger (Ceres) recognize all the Past Officers that were present.
- 28. President Campbell and National President Betsy Huber continued the discussion on what to do with the National Grange Headquarter building.

A motion was made and seconded for Pennsylvania's Delegates to vote to sell the National Grange Headquarters, motion carried.

29. Brother Douglas Bonsall, Chairman of the History Committee presented their report and some things the History Committee has been working on. Their concern is to "preserve" the records of the Pennsylvania State Grange. Since the records from the past have been preserved, the History Committee is working on preserving the future.

150 Acts of Service – please report your acts of service you do to the History Committee.

Next year they will be seeking major Sponsors. Passed out papers to all in attendance asking for the Delegates to write one word of what you believe is the main purpose of the Grange today.

The report was accepted and will appear in the Journal of Proceedings.

30. President Campbell introduced Carrie Nace, Legislative Consultant. She presented the resolutions to be archived.

A motion was made and seconded to accept the Archive Resolution list that was submitted by Carrie Nace to be archived, motion carried.

31. Brother James Huber, Chair of the Agriculture and Environmental Issues Committee presented their resolutions.

A motion was made and seconded that Resolution #2 – "Where's the Beef" should be separated into two different resolutions, motion carried.

Resolution #2 "Where's the Beef" was sent back to committee to rewrite Resolution #2 and present into two different resolutions.

A motion was made and seconded that the Resolution #3 – "Milk and Gen Youth" be rejected in its entirety because the information is incorrect, motion carried.

32. Brother Dietrich of the Government Committee continued with presenting their resolutions.

A motion was made and seconded to add "and encourage and promote basic AED operation training," at the end of the resolve for Resolution #7 "AED Tax Credits", motion carried.

A motion was made and seconded to remove "be it further resolved" and combine the two resolves in Resolution #8 "Dormancy Fees for Bank Account in Minor's Names", motion carried.

A motion to the amendment from the Government Committee was made and seconded to add the words "and invasive species" to the end of the resolve to Resolution No. 11 "Poison Hemlock", motion carried.

A motion to amend the revised motion to strike the words "noxious weeds and invasive species" be removed and add poison hemlock, motion carried. The resolve now reads –

RESOLVED: that the Pennsylvania Department of Transportation and Local Pennsylvania Townships and Municipalities, be encouraged to engage in a higher level of priority in their efforts to eradicate poison hemlock.

A motion was made and seconded in Resolution #12 "Permanent Daylight Savings" to put a period after the word round and remove the words "if the United States Congress permits states to do so", motion failed.

A motion was made and seconded on Resolution #14 "Priority Postal Delivery of Living Organisms (such as chicks and bees)" to strike the word "entity" and the word "over" and add Postal Regulatory Commission and the Postmaster General to direct", motion carried

A motion was made and seconded to put a period after priority and strike the words "in the postal delivery system", motion carried. The resolve now reads—

RESOLVED: that the Pennsylvania State Grange join with the National Grange to lobby the Postal Regulatory Commission and the Postmaster General to direct the U.S. Postal Service to make timely delivery of living organisms (such as chicks and bees) and other time-sensitive shipments be made a priority.

- 33. Door Prizes were given by the Host Committee.
- 34. A motion was made to change the Session Agenda to move the Quilts of Valor from 6:30 pm to 7:00 pm and the First and Second Degrees to follow, motion carried.
- 35. Robert Beamon and Janet Fishovitz presented Resolution #16. Committee recommended "other action" to allow the Delegate body to make a decision.

A motion was made and seconded to accept Resolution #16 – "Youth and Junior Funding Assessment" as written, motion carried.

Chairperson Jane Birk, Chair of the Good of the Order Committee presented some of their committee resolutions.

A motion was made and seconded that Resolution #19 "National Grange Theme" be rejected as originally submitted, motion carried.

- 36. President Campbell called for a recess for dinner and will resume at 7:00 pm with the Quilts of Valor, with the 1st and 2nd Degrees following.
- 37. The evening program started with the presentation of Quilts of Valor. Five quilts were presented to the following: Ray Davis, Ontelaunee Grange #1617, Berks County; Bernie Downey, Eagle Grange #1 and Allegheny Grange #1843, Lycoming County; Thomas Kehs Russellville Grange #91, Chester County; Norm Shaffer, Cumberland Valley Grange #2104, Cumberland County and David Wadsworth, Goshen Grange #121, Chester County. A very impressive program honoring these veterans for their service to their country and their fellow man. We thank you for your service.
- 38. The first and second degrees were presented by Valley Grange #1360. It was a beautiful, impressive and an excellent presentation.
- 39. Junior Grange Director Philip Vonada introduced Sadie Johnson and Harvey Reyburn, the 2021-2022 Junior Grange Ambassadors.

Sadie Johnson has been a Junior Granger since the age of five. She is a member of Hookstown Junior Grange in Beaver County. She attends South Side High School and is in the 9th grade. Sadie feels that it would be beneficial if the Grange would reach out to other organizations and give them more information of, who we are and what we can do for them and the impact that we have on agriculture.

Harvey Reyburn is a member of Russellville Junior Grange 550 in Chester County. He is in the marching band and concert band in school. He is a member of Boy Scout Troop 44 where he is a Patrol Leader. Through the Grange he has learned of some of the issues farmers face. One of the major issues of Agriculture today is that food is falsely advertised. For example, please explain to me how you milk an almond. Harvey thinks the Grange should advocate on educating people on the importance of good quality real fresh food. The Grange should continue to support young people who are interested in agriculture because this will help agriculture get the support they need.

A motion was made and seconded to reject Resolution #2 "Where's the Beef" as it was written, motion carried.

A motion was made and seconded to accept the policy statement of the Agricultural & Environmental Issues Committee, motion carried.

President/Master's Address

President's Address to the Delegate Body 2021

Worthy National President, Delegates, Officers, fellow members, and guests of the 149th Annual Session of the Pennsylvania State Grange. This past year has been a very trying year for all of us. We were fortunate to

be able to hold an in-person session last year at the Ambassador Convention Center in Erie Pennsylvania. They were excited to have us as we were their first convention since March of 2020.

The National Grange Convention is held in November and was to be held here in the Valley Forge Casino and Resort Convention Center. Many people here today had spent a lot of time researching tours, checking out transportation needs, getting a group of people lined up to iron all the 7th Degree gowns, planning a great event for Juniors from across the nation, only to have everything come to a screeching halt. This was not only people here in Pennsylvania but included Grangers all along the east coast who were a part of the Hosting committee. I would like to thank National Grange President Betsy Huber for her efforts to get the National Grange session back here as soon as possible.

December was again a very different December. Debbie and I did not attend any Grange holiday events in 2020.

January brought with it more disappointment with the cancellation of the Pennsylvania Farm Show. The Juniors and Youth Royalty normally participated in the PA Preferred Dinner and then worked in the Grange stand Saturday and Sunday. This was another experience they did not get to share in. I would like to thank Carrie Nace for arranging for participants in our virtual Farm Show meeting on Broadband and Lizzie Bailey for setting up the ZOOM and YouTube connections. This allowed us to continue to push for adequate and affordable Broadband.

I would like to thank the many Granges who continued to be an important link in their communities even as Covid 19 ravaged the state. They held drive through fund raisers, they opened their halls to serve as food distribution centers, they made masks and distributed them to those who needed them and helped in so many other ways. It truly exemplified the lesson to persevere.

February brought several ZOOM meetings on Broadband as legislators finally got the message that we live in a have and a have not world when it comes to Broadband. Students were trying to learn virtually but many had no access to the internet. Our daughter is a Special Needs teacher. She was making rounds to her students who did not have internet or who were having difficulty learning online and dropping off assignments and picking up previously dropped off assignments. No, she was not being compensated for this additional work and travel. It was dedication to seeing her students not get left behind. If you talk with many teachers, they will share similar stories.

February was the start of a new Grange journey for the Pennsylvania State Grange. I was contacted by a realtor I had been working with about a property in Juniata County that he thought might meet our needs. After three months of visits, talks, and negotiations, on May 11, 2021, at 3:00 pm we signed the paperwork purchasing the property at 26 CJEMS Ln., Mifflintown, Pa. 17059. We now have a new office for the Pennsylvania State Grange. We moved the office from Lemoyne over the Memorial Day Weekend. Thank you to the many Grangers who gave up part of their holiday weekend to assist with the move. Using a closed trailer, an 18-foot open trailer, and several cars and trucks we got almost everything into the new office. Father's Day afternoon Debbie and I moved the last pickup load of items out of 20 Erford Rd. I had advised Linlo Properties we may be purchasing a new property and again as soon as we finalized the purchase. They began looking for a new tenant as soon as I told them we may be moving. It took a while, but by mid-August they had found a new tenant. Our lease ran through July 2022, but we were able to terminate the lease effective December 31, 2021. This will save us just a little over \$20,000.00.

I did an interview with a local TV station in late February when our local physicians' offices were removed from getting the Covid 19 Vaccines. The family practice office Debbie and I rely on had over 900 people on the list when they stopped receiving the vaccine. The one point I made in the interview, rural people were not asking to be first, we were simply asking to be included. Here again it was a Broadband issue. All

appointments had to be scheduled online and many people in rural areas didn't have access. People could call their family practice.

In March I participated in training for Penn State Capitol Day which was being held Virtually. Since it was virtual you were paired with people you would have been with had it been in person as well a Penn State support person. The event was held on March 18, 2021. Although we were unable to get additional funding for the Land Grant part of the University, they maintain level funding. I encourage you to talk with your legislators about increasing this line item in the budget. They are currently being funded at a 2011 rate. This means cutting expenses which translates into lost personnel, not being able to purchase new equipment, not maintaining properties, etc. which eventually will start to show in the research they provide that keeps our farmers on top and our food supply safe, and battles things like the Spotted Lantern Fly.

Due to a severe injury, I suffered in April, I was unable to travel through mid-May. Covid 19 Vaccines were becoming more available, and Granges were beginning to have in person meetings, do more dinners, and host community events.

At the end of June, the government mandates on mask wearing, except in medical facilities, business restrictions, etc. came to an end. Vaccinations had steadily risen to a point where you could almost feel safe.

The Youth and Juniors were optimistic they could have in person camps. We were planning for and looking forward to Family Festival. The great news is all these activities went as planned and had good attendance. Thank you to everyone who helped at these functions. These are all group efforts to make them successful. Debbie and I traveled to Sturgis South Dakota along with our Grandson, Bryce Danko the National Grange Junior Ambassador, to attend the National Grange Revival. We had a wonderful time reuniting with Grange friends from across America and making new friends. We took in many of the National tourist sites and, as a group, we went to Mount Rushmore and attended the lighting ceremony. It was an amazing site, and two military jets unexpectedly flew over.

But then the Delta Variant gave rise to yet another increase in infections and deaths. Vaccination became even more important to prevent being hospitalized and preventing deaths. Unfortunately, there has been so much political turmoil in the past year, it has been hard to get anyone to focus on the common good.

We must continue to promote the Grange in all our communities. We are still one of the best kept secrets. I continue to get comments from people when I ask them if they know what the Grange is, they tell me it's that building along route so and so. We cannot expect to grow if we are not willing to let others know what we do, what we have to offer them, and most importantly, invite them in. In this time of political turmoil, we are needed now more than ever.

September brought some very exciting events. Virginville Grange #1832 in Berks County was finally able to celebrate their 100th Anniversary. They had to cancel the event twice due to Covid but were excited when we all gathered at C J Hummel's Restaurant on September 12, 2021. Debbie and I visited Eagle Grange #1 in Lycoming County on September 18, 2021, as they celebrated 150 years of continuous service. This event was followed by a dinner at the Country Cupboard Restaurant in Lewisburg Pa. where the History Committee officially kicked off the celebration of the 150th Anniversary of the Pennsylvania State Grange which we will celebrate in 2023. They had a beautiful candle lighting ceremony talking about the first 25 Granges that were started in Pennsylvania leading to the formation of the Pennsylvania State Grange. Meecee Baker gave an excellent talk that should provoke discussions among us as to how are we going to assure we are still active in another 150 years? She focused on the letter "P." Her main point was, are we willing to "pivot" or in other words, are we willing to change to maintain the Grange? The answer to that is in your hands.

Even with the political turmoil we have seen strides in the legislature over the past year. Here is a listing of actions that have been taken:

Agricultural Legislation

<u>HB101</u> provides limited liability to farms engaging in agritourism or agri-entertainment. Status: passed by the Pennsylvania House and Senate and signed into law as Act 27 of 2021. This was a big win for the Pennsylvania State Grange.

<u>SB434</u> providing for milk sell by date and best by date labeling. Status: passed by the Pennsylvania House and Senate and signed into law as Act 62 of 2021.

<u>HB187</u> limits liability for milk being donated to hunger programs. Status: passed by Pennsylvania House on February 5th and is in Senate Agriculture Committee.

<u>HB186</u> allows milk hauling during emergency. Status: passed by the Pennsylvania House of Representatives on February 4th and is in Senate Appropriations Committee.

<u>SB191</u> allowing for wedding barns to be exempted from the Uniform Construction Code. Status: Passed Senate March 2021, currently in the House L&I Committee.

Broadband

<u>HB166</u> gives municipalities the ability to become their own Internet Service Provider (ISP) if telecom companies are too slow in expanding high-speed Broadband to them. Status: In House Local Government Committee.

HB1742 funds the Broadband Authority with Federal COVID stimulus money. Status: In Consumer Affairs.

<u>HB1621</u> eases obstacles for installation of small cell facilities on utility poles. Status: Passed in House and Senate and signed into law. Act 50.

<u>SB442</u> Inventory of state properties to see where there can be a cellular add-on in rural areas (such as fire towers). Status: Passed by Senate on May 25th and in House Appropriations Committee.

<u>HB1766</u> Amends Fiscal Code, in emergency COVID-19 response, establishing the County Block Grant - Broadband Deployment and Development Program. Status: In House Consumer Affairs.

<u>SB341</u> Amends Title 66 (Public Utilities), in alternative form of regulation of telecommunications services, further providing for additional powers and duties of commission. Status: Passed by Senate on May 25th and in House Appropriations Committee

<u>SB705</u> regulates Telemedicine as an importance resource to rural PA Status: In Senate Appropriations.

2021-22 State Budget

<u>2021-22 State Budget enactment</u>: Governor Wolf's proposal to seize monies from the PA Race Horse Development Fund and use it for non-agricultural purposes. Status: The proposal was rejected as part of the State Budget passed by the General Assembly in 2021. This was another win for the Pennsylvania State Grange and Pa agriculture.

Supported increased funding for Penn State College of Agricultural Sciences and Penn State Extension. Status: enacted 2021-22 State Budget continues funding at current level, unfortunately no increase in funding was provided.

Supported continued funding for University of PA School of Veterinary Medicine. Status: Was funded in the State Budget

Advocated doubling the PASS line item in the State Budget. This program provides fresh farm products to food banks in PA. Status: PASS line item was increased in the 2021-22 state budget

As always, it was a busy year in Harrisburg, even with the Covid 19 Pandemic. Go to the Pennsylvania State Grange website and view the slide presentation under the History tab. This is a wonderful presentation to introduce new people to what the Grange is and what we have accomplished over the last 150 plus years.

- **PROVIDE** a statewide membership option.
- PURGE the policy manual as many of the policies are outdated and harmful to progress.
- **PARTICIPATE** in a statewide service project like Perry County Pomona Grange recently did (they paid 4-H dues for every youth in the county wishing to participate).

I believe that this is important food for thought for all levels of the Grange, and believe these items would be an excellent topic of discussion at your Subordinate Grange.

Thank you to everyone who has made this year successful despite the challenges, including President Wayne Campbell and all the State Officers, Lizzie Bailey, our Membership/Public Relations Director, Carrie Nace, our Legislative Consultant, and Brittney Covey, our office secretary. REPORT OF TREASURER

Worthy State Master, National and State Officers, Delegates and Members of the Pennsylvania State Grange, it is a pleasure to bring you greetings from the office of Treasurer at this 149th Annual Session of the Pennsylvania State Grange.

Today, we are reviewing financial information for the fiscal year ending June 30, 2021. My records, as well as the records of the Department Heads and State Office were forwarded to the accounting firm of Hamilton & Musser, P.C. in Mechanicsburg. The audit was performed under the direction of Zachary Smith.

As your Treasurer, I am responsible for keeping the financial records of the following accounts: the Scholarship Funds including the Leonard Rhone Grant, Ellis M. Santee Loans, Subordinate Grange Trust Funds (for both Active and Closed Granges), Subordinate Grange Improvement Loans, Lifetime Membership, Property Account, Emergency Fund and a portion of the general assets of the PA State Grange. I also manage the assets of the PA State Grange Foundation.

Scholarship Funds:

During the fiscal year ending June 30, 2021, one grant was awarded from the Leonard Rhone Scholarship Fund. This \$300 grant is available to Grange members in good standing. The student must attend Penn State and preference is given to those who pursue the study of agriculture or home economics (known today as Human Development and Family Services).

There were two (2) loans of \$2,000.00 made during the past fiscal year from the Ellis M. Santee Trust. The late Ellis M. Santee, a country doctor from Shickshinny and an active Grange member, established the Santee Student Loan program. This student loan is available to members of the Grange or children of Grange members. The Santee Loan program operates on the interest earned on the investments and is administered by Wells Fargo. These loans are to be repaid within three (3) years of graduating from or leaving school and are interest free. The program depends on the student's repayment of the loans to ensure continuation of the program.

During the fiscal year ending June 30, 2021, there were twenty-nine (29) students involved in the program. One (1) student completed the repayment of their loan during the year.

Applications are available from the State Office and can be downloaded from the PA State Grange website, www.pagrange.org. This is one of our benefits that continues to be promoted to help add and retain younger members.

Subordinate Grange/Pomona Grange Trusts:

These are funds received by Subordinate and Pomona Granges from the sale of Grange real estate. The National Grange Digest requires that these funds are to be held in trust and invested by the State Grange with no less than 90% of the interest being returned to the Subordinate or Pomona Grange every six (6) months, as long as the Subordinate or Pomona Grange remains active. The PA State Grange returns 97%. During the fiscal year ending June 30, 2021, there were one hundred-four (104) Granges with invested funds. Thirty-Five (35) of those Granges are closed. Four (4) had their assets transferred to the State Grange after having been closed for seven (7) years. Three (3) Active Granges merged their assets. One (1) moved from Active to Closed. Four (4) Closed Granges and four (4) Active Granges added funds to the trust for the first time.

Subordinate Grange Improvement Loans:

During the past year, the State Grange Master and Executive Committee continued the program of loaning funds to Subordinate Granges desiring to make improvements to their Grange properties. These funds are from the Subordinate Grange Trust funds from the sale of Granges who have surrendered their charters. These funds must be held in trust for seven (7) years in the event the Subordinate Grange would reorganize. This program invests Grange dollars back into Grange improvements. Three (3) new loans were approved during the fiscal year ending June 30, 2021. There were six (6) Granges with loans in the program. Granges interested in utilizing this program must submit an application to the State Office for approval by the State Grange Master and State Grange Executive Committee.

Lifetime Members:

As of June 30, 2021, there have been a total of 1,604 members who have become lifetime members since the program's inception in 1984. No new lifetime members were added during the Grange fiscal year due to the delegate body's decision to discontinue offering new lifetime memberships after December 31, 2019.

In closing, I thank you for your trust and confidence. The Executive Committee and I continue to look for ways to improve the return on investment for all assets of the PA State Grange, the Active & Closed Grange Trust Funds and the Grant and Scholarship Funds. I will continue to work to keep the best interest of the Grange and its membership in mind when considering future investment options.

Thank you for the opportunity to serve the Pennsylvania State Grange as the Deaf and Community Service Director alongside an amazing committee (Jacqueline Clabaugh, Denise Clare, Terra Ingram, Carlene Kleckner, Thomas Kostelansky and Cindy Shaffer). They all have provided expertise advice and guidance to continue tradition and enhance our programs this year.

My first engagement took place at Hamburg Grange on Saturday, May 8th. At that time, I discussed with their members of acts of kindness and service they have done themselves or witnessed. It was a truly heartwarming experience as I read their notes of "Sewed over 500 masks for healthcare workers" and "Sat bedside my sick spouse while he recovered from COVID". Every single act of service exemplified what it means to be a Grange member.

The second event we participated in was a virtual event hosted by the Lecturer's department where we discussed community service in the age of a pandemic. We had representatives from the State College Food Bank, PA state trainer for fire departments and EMS, Denny McClosky and Tammy Jurkowski from Progress Grange as well as subordinate members from across the state. Our hour-long discussion covered topics of what projects are available, how volunteers remained safe, and the need moving forward.

I was grateful for participating in weekly Pennsylvania State Grange Bingo, virtually of course, as I was able to meet so many members from across the state and nation that provided tidbits of how to be successful in this role. Their guidance as well as the committee's led straight up to my first-time attending Family Fest. My week was filled with meeting so many new faces as well as those very familiar from our bingo nights. Currently, we are patiently awaiting community service reports to see if we will qualify for the national program of having 25% participation as well as gearing up for State Session. We will be collecting items for a homeless shelter since Winter is approaching and will see an increase of need.

I look forward to serving the Pennsylvania State Grange into 2022 and be able to provide more service now that I have year one under completed.

REPORT OF THE YOUTH & YOUNG ADULTS COMMITTEE

Worthy Master, National Officer, State Officers, Delegates and Guests:

First, thank you to all of the Granges and individuals who sent in appeal money to the Youth and Young Adults Department. Even though our programming was still somewhat reduced this year, your donations made it possible to do some different things over the year. We truly appreciate your kindness and generosity in a year where you may not have been able to fundraise or do activities yourself but yet you still donated to support the youth. We thank you from the bottom of our hearts!

2020 NATIONAL GRANGE SESSION

Normally the youth of Pennsylvania would begin the activity year with participation in the National Grange session. The 2020 National Grange Session planning committee had several youth and young adults from Pennsylvania participating in the planning, but unfortunately the Session was pared down to a virtual session by the end of summer, with just the delegates calling in on Zoom. REPORT OF THE PA STATE GRANGE FOUNDATION

In 1994, at the State Session in Warren, Pennsylvania, the Pennsylvania State Grange Foundation was formed by delegate action. The main purpose of the Foundation then was to administer the two Grange scholarship funds established by delegate action. The Foundation has been amended twice since then to broaden its scope.

The Deaf & Community Service Department and the Pennsylvania State Grange Executive Committee oversee the Sign Language Training Program Scholarship Fund, from which a grant of \$250 is available each year. The balance of this fund as of June 30, 2021 is \$1,281.94. In 2021 we had no applications for this scholarship. We encourage anyone interested in furthering their education in this area to apply for a grant.

Also included within the funds of the Foundation is the Jonathan Sattazahn Camp Fund. The purpose of this fund is to enable more children and youth to attend the Pennsylvania State Grange Junior and Youth Camps. The balance of this fund as of June 30, 2021 is \$9,992.29

The Pennsylvania Grange Scholarship Fund provides for grants to be given to Grange members in their Junior or Senior years at any institution of higher learning, for any course of study. The State Grange Executive committee administers the funds and the State Grange Treasurer invests the funds. A scholarship committee comprised of the State Overseer, one Executive Committee member, and three additional Grange members, at least one of whom is an educator, select the grantees. The balance in this fund as of June 30, 2021 is \$97,985.74 which includes the \$1,281.94 of the Sign Language Training Programs Scholarship Fund.

REPORT OF THE HISTORY COMMITTEE

Executive Summary

In preparation for moving to the new State Grange headquarters, the History Committee stepped up its efforts to sort historical documents, excess regalia & other Grange paraphernalia, etc. housed in the Lemoyne office and then assisted with the move into the Mifflintown facility.

Another major focus during the year was planning for the 150th anniversary kick-off event held September 18, 2021, leading to the climax of the sesquicentennial celebration at the 2023 State Grange session. Planning for the session in Reading has encountered many challenges.

On-going work included the resumption of video interviews with Grange leaders to record oral history and continued organizational and facility renewal efforts at Eagle Grange #1 which officially celebrated its 150th anniversary throughout the year with many activities.

New Headquarters

The move from rented office space in Lemoyne to the Grange owned building in Mifflintown has greatly increased space available to store Grange records and other historical information. Several members of the History Committee spent a considerable amount of time sorting and organizing materials to determine what should be kept, what should be discarded and what should be moved to the new facility. The organization of the materials continue and eventually some will be on display at headquarters.

History Committee funds were expended to purchase metal shelving units to provide more orderly storage for Grange records in the new headquarters. Although we continue to encourage Granges to donate records to local historical societies for their preservation, the records of inactive Granges can now be accepted for storage at the state headquarters. A new Commonwealth Archives building is currently being constructed in Harrisburg by the State Historical & Museum so the possibility exists that at some future date Grange records will once again be accepted there and stored permanently in a climate-controlled environment.

Regalia and other Grange implements from closed Granges were provided during the year to several active Granges requesting them. Contact the History Committee if your Grange is in need of such items.

Sesquicentennial Plans/Events

The History Committee continued to fulfil its appointment by our State Grange president to provide leadership for the observance of the State Grange's 150th anniversary and the 2023 state session where the anniversary will be climaxed. Many hours of meetings, some in-person and some by Zoom, were held to make specific plans for the ideas brainstormed earlier.

Kick-Off - By the time this report is shared at the state session in Valley Forge, the kick-off events of September 18, 2021, will have been completed. This gala day of activity included an open house brunch at Eagle Grange #1, Montgomery, PA, and a luncheon with program at the Country Cupboard Restaurant & Shoppes, Lewisburg, PA. Approximately 135 persons participated. The program included the recognition of three Pennsylvanians (Leonard Rhone, John W. Scott and J. Luther Snyder) inducted into the National Grange "Hall of Fame", a thought-provoking keynote address by Dr. Meecee Baker and a original candle lighting ceremony symbolically spreading the Grange light in Pennsylvania.

Light the Cake – As of early September, candle purchases totaled \$7,130, from 42 Granges (8 Pomona and 34 Subordinate) and 65 individuals/families for an average donation of more than \$65. Thank you very

much for this generous support; see Addendum #1 for a complete list of Granges and individual/families purchasing candles. However, this is still a minority of our Granges and Grange members so we reissue the challenge to the remainder of both to contribute in whatever amount might be possible. Every donation helps us reach the goal.

150 Acts of Service – This anniversary initiative is a tangible demonstration of what the Grange is doing in local communities today. Every Grange is urged to do at least one <u>new</u> service project between 2021 and 2023 and to share that information through an on-line spreadsheet. As of mid-September, 10 acts of service have been recorded toward the goal of 150 projects.

Degree Exemplifications in Full Form – York County will be exemplifying the First and Second Degrees in 2021 at Valley Forge. At the session in York the following year (2022), the Third Degree will be exemplified by the State Youth Department and the Fourth Degree by Centre County. Finally, in 2023 the Fifth Degree will be presented by Susquehanna County and drill teams from Beaver, Centre and Chester Counties will participate in a full Pennsylvania-style exemplification of the Sixth Degree. The extra effort being given by all these Granges is much appreciated and will underscore the teachings of our historic, beautiful ritual during the anniversary celebration.

Sponsorships by Granges, individuals and Companies – Beginning in 2022, a second fundraising effort will be actively promoted seeking larger amount sponsorships to fund the anniversary celebration and the 2023 State Grange session. Each of the six sponsor levels is designated by a precious gem, the color which relates to one of the levels of the Grange:

- Diamond Sponsor (Assembly of Demeter) \$5,000 or more
- Gold Sponsor (National Grange) \$3,000-\$4,999
- Rose Quartz Sponsor (State Grange) \$2,000-\$2,999
- Emerald Sponsor (Pomona/County Grange) \$1,000-\$1,999
- Sapphire Sponsor (Local/Community/Subordinate Grange) \$500-\$999
- Ruby Sponsor (Junior Grange) \$250-\$499

Two early sponsorships have already been received, one each at the Diamond and Emerald levels for a total of \$6,000 – a great start for this initiative. See Addendum #2 for a list of sponsors.

Pomona Grange presidents were requested to appoint a Pomona coordinator for the 150th anniversary to work directly with the regional coordinators. This was intended as an important link in the chain of communications between the State and Pomona Granges with the goal of reaching every local community Grange. Despite repeated attempts, only 18 Pomona Granges have named an anniversary coordinator (20 Pomona Granges have not).

Oral History Interviews

Video interviews with Grange leaders were put on hold during the COVID lock-down and have now begun again. Thoughts and remembrances of the Grange are being recorded and will be used in various ways in the future to share the organization's history. Renewal of Pennsylvania's First Grange

Eagle Grange #1 officially reached its 150th anniversary in 2021 and many special activities took place to celebrate 150 years of continuous service. Eagle was the second Grange in the nation to be so recognized on a "150" plaque that hangs in the National Grange office in Washington, DC.

The History Committee "adopted" Eagle as a special project in 2019, determined to keep this Grange alive and to renew it. Two committee members have become Affiliate Members at Eagle and taken on leadership positions. That renewal has taken many directions – property renovation, leadership development, increased fund raising, membership recruitment, expanded community service and return to meetings in the traditional format with educational programs at each. The results have been gratifying.

In the past year, thanks to support from many Granges and the community, Eagle has completed the renovation of its facilities with the addition of commercial kitchen equipment, a new HVAC system for year-round comfort, and rehabilitation of the second floor meeting room, including installation of a chair lift. Meeting attendance has doubled with many programs and projects drawing strong interest from the community, thanks in part to an aggressive public relations effort with local newspapers and radio stations. Some new members have been received and many non-members are regular participants at Eagle Grange, creating hope that membership will continue to increase. Rebuilding this Grange, as with any Grange, is a slow and continuous process.

Miscellaneous On-Going Work

- Continue work to sort records, regalia, implements, etc. received at state office from closed Granges
- Expand the number of recorded oral history interviews with Grange leaders
- Continue work to finalize details of 150th anniversary activities and the 2023 State Grange Session
- Encourage active Pomona and Subordinate Granges to consider having their records microfilmed
- Encourage more Granges to make use of the Grange History PowerPoint program available at no charge; speakers from the History Committee are also available

Thank you for supporting the History Committee's work so the Grange story is not lost nor forgotten.

REPORT OF THE LEGISLATIVE CONSULTANT

Following are some of the highlights of Pennsylvania State Grange lobbying and advocacy from November 2021 through August 2021 following the State Session in October 2020. This report does not contain new issues added after September 13, 2021.

LEGISLATION ON WHICH THE PENNSYLVANIA STATE GRANGE LOBBIES

AGRICULTURAL EDUCATION

• Supported necessary state funding of Penn State College of Agricultural Sciences, Penn State Extension, and the University of Pennsylvania School of Veterinary Medicine. (Status: State Law).

AGRICULTURE DEPT. BUDGET

- Lobbied for strengthened PDA general government operations budget line.
- Lobbied against Governor Wolf's proposal to seize monies from the PA Race Horse Development Fund and use it for non-agricultural purposes. **NOTE: The proposal was rejected as part of the State Budget passed by the General Assembly in 2021.**

AGRITOURISM

- Lobbied for enactment of House Bill 101 that provides limited liability to farms engaging in agritourism or agri-entertainment. (Status: State Law).
- Supports SB 191 allowing for wedding barns to be exempted from the Uniform Construction Code.

BROADBAND

- Working with Grange representative to SR 47's Broadband Advisory Committee to draft legislative language as policy recommendation to the General Assembly. NOTE: Pennsylvania State Grange was the only member-based farm organization to sit on the Advisory Committee preparing the Broadband Report released summer 2020 and 2021 proposals.
- Supports HB 166 which gives municipalities the ability to become their own Internet Service Provider (ISP) if telecom companies are too slow in expanding high-speed Broadband to them.
- Supports HB 1742 which funds the Broadband Authority with Federal COVID stimulus money.
- Supported HB 1621 which eases obstacles for installation of small cell facilities on utility poles.
 (Status: State Law)
- Supports SB 442 Inventory of state properties to see where there can be a cellular add-on in rural areas (such as fire towers). **NOTE: This was opposed in 2020 by the Wolf Administration.**
- Broadband access was the top legislative priority for Pennsylvania State Grange. In January 2021, we held our fourth annual Broadband program at the Farm Show virtually which attracted a crowd and considerable media attention.

NOTE on Broadband:

Although a good track record, this is just the continuation toward our efforts to make sure there is universal access to Broadband in Pennsylvania. The Broadband issue is to this century as Rural Electrification was to the 20th Century. Not succeeding means that rural Pennsylvanians will be second-class citizens without the advantages going to others in today's ever more technology-oriented world.

COVID-19 CRISIS

• In late 2020, supported legislation providing limited liability for businesses, health care facilities, personal protection equipment from COVID liability lawsuits. Status: Passed by General Assembly but vetoed by Governor Wolf.

DAIRY

- Testified for continuance of PA Milk Marketing Board (PMMB) over-order premium.
- Supported milk sell-by legislation, SB 434. (Status: State Law).
- Supports SB 840 and SB 841 which seek to expand PA's ability to charge premium to milk coming into PA.
- Supports HB 187 to limit liability for milk being donated to hunger programs.
- Pennsylvania State Grange was represented on the PA Dairy Future Commission by member Dina Zug. She chaired the Markets subcommittee in their 2020 far-reaching report. Monitored check list of which recommendations were acted upon.
- Grange will support bills that would create Keystone Dairy Opportunity Zones to attract regional investment in dairy processing facilities when re-introduced.
- Supports HB 186 and SB 192 on milk hauling during emergency. **NOTE: This was vetoed by the Governor in the last legislative session.**

ABUSE OF POWER; ATTACK ON STATE SOVEREINTY

- Opposes the Delaware River Basin Commission's overstepping their authority by adopting a regulation banning fracking in northeast PA, ignoring established PA state law. NOTE: Act 13 already regulates natural gas development. The Delaware River Basin Commission ignored this law when it decided to ban any fracking in northeast PA. This should NOT be construed as a position on fracking. Rather, it is whether PA law can simply be ignored by a regional entity.
- Opposes Governor Wolf's unilateral decision to have PA join the Regional Greenhouse Gas Initiative (RGGI) without legislative approval. Besides the Grange position opposing cap and trade schemes, the Pennsylvania State Grange also stresses that the PA Constitution explicitly says no to PA surrendering the power to tax to an outside entity. RGGI would have the power to tax coal energy producers out of existence.

ENVIRONMENT & FARMLAND PRESERVATION

- Supports continued funding for conservation programs, Growing Greener III, and dedicating funding for farmers to adopt conservation best practices. SB 832; SB 525.
- Providing input and testimony on proposals regarding use of solar energy to legislators.

FAIRS

• Supports continued state support disbursements to County Fairs, particularly to continue payments for operations such as Fair liability insurance policies.

FEDERAL

- Urged USDA to allow whole milk as part of the Nutrition Guidelines and contacted PA congress people re the same.
- Monitored activity of Family Business Coalition which opposes a Federal Death Tax.
- Re-enforced National Grange legislative positions.

HEALTH

- Opposes SB 38 that would establish the False Claims Act in PA. NOTE: Because the bill still punishes
 anyone who makes an unintentional mistake in a contract with the state and corrects, it, the
 Pennsylvania State Grange holds that rural hospitals and managed care companies having
 Medicaid contracts would be unfairly fined.
- Supports SB 705 and HB 1573 that would regulate Telemedicine as an importance resource to rural PA providing that attention is paid to expanding access to high-speed Broadband.

- Supports HB 1729 and HR 68 in concept regarding insurance company payment for Tele-dentistry with the caveat that there must be Broadband access for this legislation to be effective.
- Will support legislation when re-introduced to mandate insurer coverage for hearing aids.

HUNGER

- Advocated doubling the PASS line item in the State Budget. This program provides fresh farm
 products to food banks in PA. NOTE: PASS line item was increased in the 2021-22 state budget
- Supported local community and vertical farming organizations focused on feeding communities.

HUNTING

- Opposes SB 607 to eliminate all restrictions on hunting during deer season.
- Opposed SB 147 in 2020 and was the only farm group which consistently opposed Sunday hunting.
 NOTE: Enacted into law despite Grange opposition.

MARCELLUS SHALE ROYALTIES

• Supports royalty transparency, SB 806.

MEDIA LEGISLATION

Opposes HB 955 which would give municipalities the option of posting legal notices on line instead
of placing ads in newspaper. NOTE: The Grange works with PA newspapers association on this bill
and submitted testimony supporting the position.

PROPERTY TAXES

• Will support legislation when introduced to exempt "historic agricultural buildings" from local property taxes. NOTE: Drafted alternate property tax exemption bill for Grange halls – drafted but not introduced in 2020 or 2021.

RETIREMENT

 Will oppose legislation if re-introduced that would establish a state retirement plan for small businesses. NOTE: It would be mandatory for small businesses to participate. Employees would be automatically enrolled with premiums coming out of their paychecks although they could opt-out but the onus is on them to do so.

RIGHT TO FARM/ AGRI-TOURISM

Supports HB 216 which curtails unreasonable municipal restrictions on agritourism.

RIGHT TO REPAIR

• Monitors HB 1152 Right to Repair legislation; No Grange lobbying position taken.

SEPTIC SYSTEMS

 Will support legislation when re-introduced to exempt DEP regulation of PA septic systems from oversight by Delaware River Basin Commission. NOTE: DEP estimates that approximately onequarter of PA homes have septic systems.

STATE BUDGET

- Supports increased PDA general government operations budget. (Status: State Law.)
- Worked to restore PDA line items such as hardwoods, ag research, ag exports & marketing, etc. that were cut in the Governor's 2021 State Budget proposal. (Status: State Law.)
- Supported increased funding for Penn State College of Agricultural Sciences and Penn State Extension. *NOTE: enacted 2021-22 State Budget continues funding at current level.*
- Support continued FY 2021-22 funding for University of PA School of Veterinary Medicine. (Status: State Law.)

 Successfully fought efforts by some legislators to take away Vet School funding because of an unrelated COVID issue.

STATE BUDGET BORROWING

- Opposes legislative attempts to raid Special Funds, HB 255.
- Opposes Governor Wolf's Restore PA plan and its successors which would borrow billions of dollars and repay the loan by a severance tax on natural gas extraction. **NOTE:** Grange opposed because that assumes an adequate revenue stream to pay back the loan.

TAXES

• Re MS4 (Rain Tax) will support legislation when introduced re reduced farm Rain Tax for farmers and Resolutions asking Congress to repeal MS4.

TRANSPORTATION

Supports HB 37 to ban use of hand-held electronic devices by driver while car is in motion

URBAN AGRICULTURE

 Researching vertical farming. Grange has been active in meeting with owners of facilities and supporting these efforts.

PENNSYLVANIA STATE GRANGE RESOLUTIONS adopted by the GENERAL ASSEMBLY

• None in 2020 or 2021.

MEMBER LEGISLATIVE ACTIVITY

Individual member legislative activity reduced significantly due to COVID-19.

Constant Contact/Email Blasts, Social Media, Website

Personal Touch - I made phone calls and sent cards to reach out and provide a personal touch during the pandemic. If there is anything you need or just want to chat to catch up on news, please contact me.

Pennsylvania Grange News - This has been a big undertaking by everyone at the State Grange office. Brittany Covey and I have assumed the role of Publishing Editors. There have been many challenges along the way with content, layout, writing articles, and gathering enough Grange news overall. We are not perfect, but we are giving this project our all. We rely on Grange volunteers to help us accomplish these news editions. We could use your help in editing, writing, and gathering information from your Grangers. PA State Grange Lecturer's Workshop Series - I participated in the Lecturer's Workshop series on hosting a Zoom Membership meeting. It was an open discussion on growing membership. Plans are now in the works for Harrisburg area youth to paint blocks for the passage way outside the Small Arena.

Once again, the Paint Your Own Quilt Block Workshop was held at Family Festival with 15 blocks painted including one for the Pennsylvania State Grange's new office building. A 4' x 4' patriotic themed block was chosen to hang on the north side of the building for all to see when traveling south into Mifflintown.

Due to the pandemic, we were not able to hold Paint Your Own Quilt Block workshops throughout the year however we were able to work with a Venango County 4-H Club who painted 13 new 2' x 2' blocks bringing the total number of Quilt Blocks hanging on the Venango County Fairground buildings to 50!

Hopefully we will be able to hold the Paint Your Own Quilt Block workshops in the coming year. Classes are presented by Barbara and Glenn Gross as requested throughout the year. Granges as well as other groups may request a program presentation with a daylong workshop where they paint their own block.

Work is ongoing on our PA Grange Heritage Quilt Trail website to keep it up to date with current photos and locations of Quilt Blocks. Remember that the PA Grange will provide every Grange sponsored Quilt Block with a PA Grange Heritage Quilt Trail sign at no cost. If you have a Grange sponsored Quilt Block or know of one without signage, please contact us to receive either a 2' or 4' sign. To register your Quilt Block with the PA Grange Heritage Quilt Trail and have it listed on the website, fill out the form on line and send a photo of your mounted Quilt Block to the State Grange Office.

AGRICULTURE & ENVIRONMENTAL ISSUES APPROVED RESOLUTIONS

Resolution #1 — Solar Farms

Walker Grange #786

RESOLVED: that the Pennsylvania State Grange opposes the granting of permits or zoning approvals for construction of solar generating facilities on productive Class 1 and Class 2 PA farmland; and be it further **RESOLVED:** that the dual usage with solar may be considered where the solar panel structures do not inhibit what is considered normal agronomic production.

Resolution #1A — Solar Development

AG Committee

RESOLVED: The Pennsylvania State Grange endorses the development of alternative energy sources by agricultural enterprises to meet their own needs; and be it further

RESOLVED: that if alternative power in excess of an agricultural enterprise needs can be generated from roof areas or land areas or by other means without adversely affecting agriculture or nature of the operation, it may be considered part of the agricultural operation.

Resolution #5 — Establishment of Pennsylvania Dairy Production Tax Credit Elizabethtown Area Grange #2076

RESOLVED: that the Pennsylvania State Grange seek an amendment to the Commonwealth of Pennsylvania Tax Code establishing a Dairy Farmer Tax Credit program, which would provide tax relief in the form of a credit, and be it further

RESOLVED: that the tax credit would only be triggered by predetermined statewide average profit margins and metrics, acting as a safety net of revenue stability when either milk prices paid to farmers fall or costs of production rise relative to one another; and be it further

RESOLVED: the tax credit would be based on the volume of milk produced and sold by each individual farm.

REPORT OF THE AGRICULTURAL AND ENVIRONMENTAL ISSUES COMMITTEE POLICY STATEMENT

Worthy President, State Officers, Delegates, Brothers and Sisters:

The members of the Agricultural and Environmental Issues committee are again honored to serve the members of the Pennsylvania State Grange. We have reviewed the resolutions presented to our committee with an open discussion and have presented them in a way that we feel best represents the interests of our members.

The Pennsylvania State Grange is challenged each year with issues relating to food quality, straightforward advertising and fair marketing practices. The year 2021 has brought additional items to the attention of the AG Committee.

- 1. The Pennsylvania State Grange endorses the efforts to develop alternative energy sources. Pennsylvania has programs for homeowners for supplementing personal energy needs. Utilities are leasing large tracts of land for solar farms. Many rural municipalities currently have no regulations or plans for alternative energy implementation.
- 2. With this endorsement the Pennsylvania State Grange strongly encourages Local Governments to consider the important rolls of agriculture and the harvesting of energy and provide an opportunity for them to be complementary. The Grange is concerned with utility companies creating large solar farms on lands that are suitable for highly productive row crops that help sustain other local businesses.
- 3. The Pennsylvania State Grange will continue to encourage legislation for true and accurate labeling on processed foods.
- 4. The Pennsylvania State Grange will initiate an amendment to the Commonwealth of Pennsylvania Tax code to create a tax credit for dairy producers to be used when milk prices drop or when input costs rise to an unprofitable level.
- 5. The Pennsylvania State Grange will continue to support the actions of the Dairy Future Commission established by the Pennsylvania Legislature in regular session 2019-2020 as part of ACT 66. This Commission has been given five years to evaluate and make recommendations for resolving issues at the farm, state, market and consumer levels.

GOVERNMENTAL ISSUES

Resolution #7 — AED Tax Credits

Valley Grange #1360

RESOLVED: that the Pennsylvania State Grange support legislation that offers tax credits to businesses and organizations that purchase and maintain an AED on their premises and encourage and promote basic AED operation training.

Resolution #8 — Dormancy Fees for Bank Account in Minor's Names

Berks County Pomona Grange #43

RESOLVED: Pennsylvania State Grange recommends the passage of legislation eliminating any dormancy fees for accounts held by a minor that such legislation also requires banks to notify any account owner (both the minor and the parent or guardian listed on the account) of the change in status of the account six months prior to the minor's 18th birthday.

Resolution 9 — Permanent Identification

Berks County Pomona Grange #43

RESOLVED: that during elections voters produce a state or federal form of identification and poll workers shall be required to confirm signatures and identities.

Resolution #11 — Poison Hemlock

Walker Grange #786

RESOLVED: that the Pennsylvania Department of Transportation and Local Pennsylvania Townships and Municipalities, be encouraged to engage in higher level of priority in their efforts to eradicate poison hemlock.

Resolution 12 — Permanent Daylight Savings

Berks County Pomona Grange #43

RESOLVED: that Pennsylvania and the United States move to permanent daylight-saving time as soon as feasibly possible; and be it further

RESOLVED: that the Grange support House Bill 335-2021 or similar legislation, which allows Pennsylvania to follow daylight saving time year-round if the United States Congress permits states to do so.

Resolution #14 — Priority Postal Delivery of Living Organisms (such as chicks and bees) Plumsteadville Grange #1738

RESOLVED: that the Pennsylvania State Grange join with the National Grange to lobby the Postal Regulatory Commission and the Postmaster General to direct the U.S. Postal Service to make timely delivery of living organisms (such as chicks and bees) and other time-sensitive shipments be made a priority.

GOVERNMENT ISSUES COMMITTEE POLICY STATEMENT

Worthy President, Wayne Campbell, officers, delegates of the Pennsylvania State Grange and guests. The Government Issues committee wishes to thank President Wayne Campbell for his promoting the policies of the Pennsylvania State Grange on local, state, and national issues. We want to recognize and thank Carrie Nace, PA State Grange Legislative Consultant for providing facts for our resolutions committee.

The committee reviewed 10 proposed resolutions.

<u>AED Tax Credits #7</u> – The Pennsylvania State Grange will urge state legislators to offer tax credits to businesses and organizations that purchase and maintain AEDs on premises and provide training.

<u>Dormancy Fees for Bank Accounts: #8</u> – The Pennsylvania State Grange recommends legislation eliminating dormancy for accounts held by minors and require banks to notify account holders six months in advance of their 18th birthday of the change of status.

<u>Noxious Weeds #11</u> – Invasive species are threatening our valuable resources. The Pennsylvania State Grange recommends that the state and federal government and landowners work together to increase awareness of the issue and implement programs to control invasive species to preserve the value and productive capacity of state, federal, private farmland and woodlands.

Priority Postal Delivery of Living Organisms #14 – the Pennsylvania State Grange joins with National Grange to lobby the Postal Regulatory Commission and the Postmaster General over the U.S. Postal Service to make timely deliveries of living organisms such as bees, chicks and other time sensitive shipments made a priority.

Resolution #17 — 2023 Session Location

RESOLVED: that the Executive Committee of the Pennsylvania State Grange, upon recommendation from the History Committee, be authorized if necessary to change the site of the 2023 session from Reading to another location with facilities able to accommodate the many special events that are planned for the 150th anniversary celebration, and be it further

RESOLVED, that a reminder be issued that the 2019 delegate action urged all Granges in Pennsylvania to accept responsibility and contribute toward the costs to host the 2023 convention rather than the financial responsibility being borne by any one region of the state.

Resolution #23 — 2023 Junior Grange Ritual

Pennsylvania State Grange Junior Committee

RESOLVED: that the National Grange examine updating the language of the Opening, Closing, and other ritual used in the Junior Grange to a more contemporary language that is easier for children to learn and understand, while retaining the similarities to the Subordinate/Community Grange ritual.

Resolution #24 — Departmental Committee Members

Pennsylvania State Grange Good of the Order Committee

RESOLVED: that Section 1.8.1 of the Pennsylvania State Grange By-Laws be changed to read as follows:

1.8.1 Departmental Committees of the State Grange, unless otherwise ordered, shall consist of six members, one representing each region. Other standing and special committees may be appointed as needed by the President/Master and Vice President/Overseer.

Resolution #25 — Family Membership Pennsylvania State Grange Good of the Order Committee

RESOLVED: that Section 1.3.8 of the Pennsylvania State Grange By-Laws be changed to read as follows:

- 1.3.8 Family Membership A family whose members are fourteen years of age (thirteen years and six months or more) with an interest in the purposes of the Order may be proposed as candidates and, upon payment of the annual dues as prescribed in Article X, Section 1.10.5, be elected to membership in a Community/Subordinate Grange as follows:
 - A. The process of election to membership and becoming a full member for all members of the family shall be the same as for an individual.
 - B. A family shall consist of a couple and their dependents, or a single person and their dependents. Dependents are defined as children, grandchildren, great grandchildren, foster, adopted or step-children under the age of 23, who live as a member of the same household or in absence due to illness, education or military service. Legal dependents of any age shall be considered part of their legal guardians' family.
 - C. At such time as a member no longer qualifies as a dependent, the status of the member shall be as an individual with no interruption of their membership.
