# **DAVID B. MAUGER**

## 1<sup>st</sup> MASTER OF THE PENNSYLVANIA STATE GRANGE (1873-1876)

#### The Person:

- David B. Mauger was born in Douglass Township, Berks County August 12, 1822.
- He married Mary Amanda Lorah in 1851, and they had four children.
- At age 18 opened a subscription school in Pottsgrove Township, Montgomery County.
- In 1842 he took charge of an academy at Douglassville for seven years. During that time he studied surveying.
- For 16 years he followed teaching in connection with surveying and conveyance.
- At age 34 he purchased a farm in Douglass Township where he resided for the remainder of his life.
- He served for 55 years as a Justice of the Peace, and was a member of the Board of Managers of the Perkiomen & Reading Turnpike Company and became Secretary in 1872.
- He was a Charter member of the first Subordinate Grange organized in Berks County, Amity #4, and later transferred to Adams Grange #18 established August 18, 1873 in Douglassville.
- The PA State Grange was formed September 18, 1873 in Reading and he became the first Master serving until 1876 when he voluntarily retired.
- He died April 2, 1906 at the age of 84.

#### Of Note:

- January 7, 1874 first annual meeting held at Patriarch Grange #42 in Harrisburg. (Additional information included below)
- From September to January the number of Subordinate Granges increased from 25 to 74.
- Seal of State and Subordinate Granges adopted.

#### Legislative Activities:

- 1. Re-enactment of law where lender charging more than 6% interest was penalized by the loss of both principle and interest.
- 2. Act making it easier for farmers to collect damages from railroads for property damage or destroyed by fire of passing locomotives.
- 3. Compel railroad companies to furnish cars to shippers particularly for anthracite and bituminous coal.
- 4. Opposed owning of real estate by railroad companies beyond reasonable needs.
- 5. Provide for reasonable freight and passenger charges and prohibit unjust discrimination.
- 6. Make public highways free to all



### Additional Information:

- Thomas L. Smith, Past Master of North Star Grange, MN and National Lecturer T. A. Thompson in attendance at the first Annual Meeting in Harrisburg January 7, 1874.
- Emphasis on savings through cooperative purchase of machinery and supplies.
- Mr. Mauger was authorized to act as purchasing agent until a permanent appointment made.
- The Fifth Degree conferred on Masters, Past Masters and wives during the meeting.
- <u>Farmers Friend & Grange Advocate</u>, became first weekly paper consisting of eight pages January 3, 1874.
- Paper edited by R. H. Thomas and was the official organ of the Grange.
- Special session held in Mechanicsburg June 10, 1974 with 129 Masters in attendance.
- Motion adopted that women be represented on all committees in the future.
- No discussion of political or religious subjects permitted in Grange rooms.
- County Councils organized to look after cooperative work and serve as purchasing agencies. Councils were replaced by Pomona Granges at a later date.
- Organized Grange Life and Fire Insurance Company.
- Second Annual Session held in Williamsport January 6, 1875 at Lycoming County Courthouse. Noted that there were 440 Granges with 18,000 members.
- Legislation requested the following:
- Amendment to change meeting to the second Tuesday in December.
- Third annual session held December 14, 1875 at the Lancaster Courthouse.
- Subordinate Granges numbered 630 indicating 190 were new Granges and 14 ceased to exist leaving 616 active Granges. As of September 30, 1875 there were 25,000 members.
- Executive Committee instructed to Incorporate. Charter issued August 9, 1875.
- C. E. Gladding appointed as the first State Business Agent. Office located in Philadelphia.
- December 12, 1876 Annual meeting held at the Crawford County Courthouse, Meadville.
- Confronted with serious financial issues. Samuel Downing, Chester County moved a \$10,000 note be drawn and sufficient number of endorsers be secured to make the note acceptable.
- Plan adopted and 30 signers secured, but only 23 were recorded in the minutes.
- Also an issue was the stock of Patron's Centennial Encampment Association organized for the purpose of building a hotel near the grounds of Centennial Exposition at Philadelphia.
- Hotel caught fire and totally destroyed along with the records of the Association.
- Reported at the Meadville session were 98 new Granges organized making a total of 728 since the beginning of the Organization. A total of 200 were classified as being delinquent in payment of dues. As of June there were 28,000 members on the roll. Eight more Pomona Granges were organized.
- Victor E. Piollet elected Master.
