- Approved a resolution asking that tattoo and piercing artists undergo professional training and that parlors be regularly be inspected for safety and cleanliness.
- Delegates voted to support an increase of "in lieu of taxes" payments on state forest and game lands from the current \$3.60 per acre to \$6.00 per acre, to be paid to local municipalities and school districts and the county.
- Delegates approved a resolution favoring the legalization of the use of semi-automatic rifles for hunting.
- The Grange favors amending the Hatch Act to allow federal government employees to run for and be elected to local municipal and/or county offices.

- The Delegates approved a resolution to require all individuals over the age of 18 secure a clearance under Act 33 and Act 34 in order to work with children and youth under the age of 18.
