The Person

Betsy E. Huber was born and raised on the family dairy farm in Westtown, Chester County PA. She is a third generation Grange member, active in Goshen Grange #121 and Chester/Delaware Pomona Grange #3. She served as the first woman Master of Goshen.



Betsy married Henry T. Huber in 1966 and the had three children- Ellen Marie, Peter, and Andrew. She and Henry were selected as the PA Grange Young Couple of the Year in 1971.

She was elected Supervisor of Upper Oxford Township serving for 24 years (first woman). Served on several committees for PA State Association of Township Supervisors and the Chester County Association. In 2004 she received the Award for Distinguished Service to Agriculture in Chester County.

While State Master she served on many state committees. Chair of DEP Ag Advisory Board, President of PA State Council of Farm Organizations, Secretary of PA Farm Link, Trustee, Penn State University 2005-17.

First woman elected PA State Grange Master 2002. Elected to a fourth term by a "write-in" vote, as her name could not appear on the written ballot according to the By-Laws. Five new Granges were organized during her term.

Elected to National Grange Executive Committee 2006-14, Chair 2007-14 and elected National Master in 2015. (first woman)
